NORTHERN IRELAND OFFICE

Notice is hereby given that the Secretary of State in pursuance of sections 4 and 14 of the Legal Aid and Advice Act (Northern Ireland) 1965, and with the concurrence of the Treasury, has made a Statutory Rule entitled Legal Aid (Assessment of Resources) Regulations (Northern Ireland) 1980 (SR 1980 No. 402).

These regulations consolidate, with amendments, the Legal Aid (Assessment of Resources) Regulations (Northern Ireland) 1965 and subsequent amending regulations. They incorporate amendments required by the Social Security Order (Northern Ireland) 1980 — assessment by officers of the Department of Health and Social Services will replace assessment by the Supplementary Benefits Commission which is being abolished. A number of minor changes have been made to give a fuller assessment of an applicant's resources.

Notice is hereby given that the Lord Chancellor, in pursuance of section 23 of the Magistrates' Courts Act (Northern Ireland) 1964 and Article 41(6) of the Domestic Proceedings (Northern Ireland) Order 1980, on the advice of the Magistrates' Courts Rules Committee, and after consultation with the Lord Chief Justice, has made a Statutory Rule entitled the Magistrates' Courts (Amendment No. 4) Rules (Northern Ireland) 1980. (SR 1980 No. 409).

These rules which come into operation on 1st December 1980 amend the Magistrates' Courts Rules (Northern Ireland) 1974 by inserting rule 132A and by adding Form 183 to Schedule 1. These additions to the Rules lay down a procedure under which a person imprisoned under a warrant of commitment issued under section 114 of the Magistrates' Courts Act (Northern Ireland) 1964 (and who is not detained otherwise) may apply, in accordance with section 114A of that Act, for cancellation of the warrant.
