NOTE.—The holding when vested in the purchaser shall continue to have appurtenant thereto, and to be subject to, as the case may be, any previous existing easements, rights and appurtenances.

Any person objecting to this List by reason of the inclusion or non-inclusion therein of any land may lodge his objection on or before the 11th day of February, 1929.

Such objection must be in conformity with the requirements of Order IX of the Provisional Rules dated the 29th day of May, 1925, made in pursuance of the Northern Ireland Land Act, 1925.

In case the non-judicial holding set out in the above List becomes vested in the Commission under the Act the Standard Purchase Annuity in respect of such holding shall, as has been done above, be calculated in the manner specified in the Third Schedule to the Act as if the non-judicial Rent were a second term Judicial Rent, unless an objection is lodged on or before the 22nd day of February, 1929. Such objection must be in conformity with the requirements of Order XIII of the said Provisional Rules.

If any person, not being merely a chargeant or incumbrancer, objects on the ground that he has any interest in the land other than is stated in the above List or that his interest therein is incorrectly stated, or for any other reason, he must lodge his objection in the Registrar's Office of the Commission on or before the 11th day of February, 1929. Such objection must be in writing and must be signed by the Objector or his Solicitor, and must be served on the persons and in the manner set out in Order IX of the said Provisional Rules.

Pursuant to Order VII of the said Provisional Rules the Owners have given the name and address of Messrs. Martin, King, French & Ingram, Solicitors, Dungiven, Co. Londonderry, as the name and address of the persons to be served on behalf of the Owners with all objections to the above List.
