This Order consolidates Part I of the Planning and Land Compensation Act (NI) 1971 and the enactments amending that Part.

THE PUBLIC ORDER (NI) ORDER 1981

This Order consolidates the Public Order Act (NI) 1951 and the enactments amending that Act.

THE QUEEN'S UNIVERSITY OF BELFAST (NI) ORDER 1981

This Order repeals certain statutory provisions relating to the Queen's University of Belfast. The provisions are spent or unnecessary, or will become so upon the granting of a new charter to the university.

ENTERPRISE ZONES (NI) ORDER 1981

This Order provides for the designation by the Department of the Environment of certain areas as enterprise zones to which schemes prepared by the Department relating to the development of the area will apply. It makes special provision for the granting of planning permission in such enterprise zones, and exempts from rates certain hereditaments situated in enterprise zones and provides for the increase of the derating element of the General Grant payable to district councils to compensate them for loss of revenue in consequence of such exemptions.

The Department of Agriculture has made a Statutory Rule entitled The Milk Marketing (Amendment) Regulations (Northern Ireland) 1981. These Regulations further amend the Milk Marketing Scheme (Northern Ireland) 1955 to bring it into line with the requirements of Council Regulation (EEC) No 1422/78 and of Commission Regulation (EEC) No 1565/79. (SR 1981 No 119).

The Milk Marketing (Amendment) Regulations (Northern Ireland) 1981 provide for the following matters:

- (a) the placing of the Board's commercial activities under a separate system of financial management and administration from their statutory function in the purchase and sale of raw ex-farm milk;
- (b) the withholding of milk from the Board by pro-ducers wishing to export milk or to convert it into butter or skimmed milk powder for sale into Intervention;
- (c) the conditions under which certain producers who wish to sell their milk direct to the final consumer may be exempted from the obligation to sell milk to the Board;

- (d) the negotiation between the Board and the purchasers of milk of different prices for milk according to the use to which the milk is put;
- an obligation on the Board to purchase all milk offered to them by registered producers.


