### DEPARTMENT OF FINANCE

The Department of Finance has made an Order entitled Compulsory Acquisition (Interest) Order (Northern Ireland) 1981 (SR 1981 No 122) which prescribes as from 18th May 1981 13½% per annum as the rate of interest on compensation monies payable in respect of land compulsorily acquired under certain enactments.

The Department of Finance has made an Order entitled Interest on Recoverable Sanitation Expenses Order (Northern Ireland) 1981 (SR 1981 No 123) which prescribes as from 18th May 1981 13½% per annum as the rate of interest on certain expenses recoverable from owners of premises under the Public Health (Ireland) Act 1878.

The Department of Finance in exercise of the powers conferred by section 7(4A) of the Administration of Estates Act (Northern Ireland) 1955 has made a statutory rule entitled the Administration of Estates (Rights of Serviving Spouse) Order (Northern Ireland) 1981. (SR 1981 No 124). This rule increases the amounts of the surviving spouse's statutory legacy so that the surviving spouse of a person who dies intestate will take the first £40,000 of the estate if there are children also surviving and £85,000 where there are no such children. The previous amounts were £25,000 and £55,000 respectively. The rule shall come into operation on 1st June 1981.
