DEPARTMENT OF THE ENVIRONMENT

The Department of the Environment has made a Statutory Rule entitled Motor Vehicles (Maximum Speed) (Amendment) Regulations (Northern Ireland) 1981 (S.R. 1981 No. 135).

This rule comes into operation on 1st June, 1981, and amends the Motor Vehicles (Maximum Speed) Regulations (Northern Ireland) 1973 (which specify the maximum speeds at which certain vehicles may travel on roads other than motorways).

The main effect of the amendments is to impose a speed limit of 18 miles per hour on industrial tractors (whether or not they are being used as goods vehicles) and works trucks and to define the terms "industrial tractor", "living van" and "works truck".

THE CLEAN AIR (NORTHERN IRELAND) ORDER 1981

The Belfast (No. 18) Smoke Control Order (Northern Ireland) 1981

1. Notice is hereby given that the Belfast City Council, in exercise of the powers conferred on them by Article 17 of the Clean Air (Northern Ireland) Order 1981 on the 5th day of May, 1981, made an Order entitled the Belfast (No. 18) Smoke Control Order (Northern Ireland) 1981, declaring the area described in the schedule hereto to be a smoke control area, which Order is about to be submitted to the Department of the Environment for confirmation.
2. Subject to the exemptions provided by virtue of Articles 17 and 25 of the Clean Air (N.I.) Order 1981, if on any day after the Smoke Control Order has come into operation, smoke is emitted from a chimney of any

building within the smoke control area, the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

3. Copies of the Smoke Control Order and of the map referred to therein may be inspected free of charge at the Environmental Health Department, City Hall, Belfast until 9th July, 1981.
4. Within the said period any person who will be affected by the Smoke Control Order may by notice in writing to the Secretary, Department of the Environment, Stormont, Belfast, BT4 3SS object to its confirmation.
