**WIRELESS TELEGRAPHY ACT 1949** 

Variation of Terms of Ship Licences

The Secretary of State for the Home Department hereby gives notice to all holders of Ship Licences for the establishment and use of Ship Stations for Wireless Telegraphy of the variation of the terms of such licences as follows:

The terms of each such licence issued before 1st January 1982 shall be and are hereby varied by the deletion of clause 1.2(a) and replaced by the following: "When used for sending, the Ship Station shall be used only with emissions which comply with the requirements of the Radio Regulations for the time being in force under the Telecommunication Convention, and with a power not exceeding that permitted by those Regulations, and on the frequencies specified in the First schedule hereto." Clause 2.2(a) should also be deleted and replaced by the following: "When used for sending the Lifeboat Stations shall be used only with emissions which comply with the requirements of the Radio Regulations for the time being in force, under the Telecommunication Convention, and with a power not exceeding that permitted by those Regulations, and on the frequencies specified in the Second Schedule hereto." Any reference to classes of emission or power in the First and Second Schedules should be deleted.

NOTE: The Scheme which follows this note has been made NOTE: The Scheme which follows this note has been made under Section 28 of the Post Office Act 1969 and amends the Post Office Inland Post Scheme 1979. The Scheme, which will come into operation on 1st February 1982, provides for postage rates and fees generally to be increased, extends the scope of the registered newspaper service to publications printed and published in any member state of the European Economic Community, and introduces provisions for earlier delivery of business raply introduces provisions for earlier delivery of business reply and freepost packets.

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and citation

1.—(1) This Scheme shall come into operation on 1st February 1982 and may be cited as the Post Office Inland Post Amendment (No. 9) Scheme 1982.

(2) This Scheme shall be read as one with the Post Office Inland Post Scheme 1979 (Post Office Scheme P1/1979) (hereinafter called "the Scheme") as amended by the Post Office Inland Post Amendment (No. 1) Scheme 1979 (Post Office Scheme P5/1979), the Post Office Inland Post Amendment (No. 2) Scheme 1980 (Post Office Scheme P1/1980), the Post Office Inland Post Amendment (No. 3) Scheme 1980 (Post Office Scheme P6/1980), the Post Office Inland Post Amendment (No. 4) Scheme 1981 (Post Office Scheme P1/1981), the Post Office Inland Post Amendment (No. 5) Scheme 1981 (Post Office Scheme P1/1981), the Post Office Inland Post Amendment (No. 6) Scheme 1981 (Post Office Scheme P11/1981), the Post Office Inland Post Amendment (No. 7) Scheme 1981 (Post Office Scheme P12/1981) and the Post Office Inland Post Amendment (No. 8) Scheme 1981 (Post Office Scheme P15/1981).

#### Business reply packets and postage forward parcels

  - "(11) If the Post Office at the request of the licensee delivers business reply packets to an address of the licensee by the first delivery of any day on which the Post Office ordinarily makes more than one delivery of postal packets to that address, the licensee shall pay such charge as the Post Office may from time to time determine in respect of each business reply packet delivered by such first delivery, in addition to the postage and fees otherwise payable."

THE IMPORTED FOOD (NORTHERN IRELAND) **REGULATIONS 1968** 

Luxembourg: Official Certificate

The Department of Health and Social Services with the approval of the Minister of Agriculture, Fisheries and Food and the Secretary of State for Wales gives notice

that, in exercise of the powers conferred on it by the Imported Food (Northern Ireland) Regulations 1968 as amended by the Imported Food (Northern Ireland) (Amendment) Regulations 1973, 1979 and 1981 it hereby recognises each Official Certificate described in Part I of the Schedule hereto for the importation from Luxembourg of meat or cured or smoked meat and meat products respectively as showing:

- (a) that the meat, or cured or smoked meat to which it relates, or the meat or poultry meat from which the meat product to which it relates was prepared, was derived from mammals or poultry inspected before and after death in the country of origin of the meat and passed in accordance with criteria satisfactory to the Minister; and
- (b) that the dressing, packing and other preparation of the meat, cured or smoked meat or meat product was carried out with all necessary precautions for the prevention of danger to health.

With regard to meat, recognition of the Official Certificate is extended to include:

- carcases or portions of carcases comprising recognisable wholesale or retail cuts, with or without bone, which contain no associated lymphatic glands or from which any pleura, peritoneum or lymphatic gland has been removed.
- (b) any offal from which any lymphatic gland has been removed provided that such offal has not been separated from the carcase;
- stomachs (tripes and maws) from which any lymphatic gland has been removed;
- tongues from which the submaxillary lymphatic gland has been removed.

The said Official Certificates are recognised subject to the following conditions:

- (i) Where the Official Certificate is in the form of a label, recognition will apply only if the label is securely affixed to the meat or to the meat product, or to the package containing the meat or the meat product and if the label has not in any other circumstances or on any other occasion been used as an Official Certificate;
- (ii) Where the Official Certificate is in the form of a stamp or mark recognition will apply only if the stamp or mark is clearly impressed or otherwise marked on the meat or meat product or on the package containing the meat or the meat product;
- (iii) Recognition will apply only if each consignment of meat products bearing the said Official Certificate for cured or smoked meats or meat products is accompanied by a properly completed Health Certificate in the form prescribed in the Schedule to the Notice published in the London Gazette dated 29th June, 1979;
- (iv) Recognition of the Official Certificates is restricted to the extent shown in Part II of the Schedule.

The Notice published in the Belfast Gazette dated 21st September 1973 is hereby revoked.
