DEPARTMENT OF INDUSTRY

BRITISH TELECOMMUNICATIONS ACT 1981

(c. 38)

Licence under Section 68.

1. The Secretary of State, in exercise of the powers conferred on him by section 68 of the British Telecommunications Act 1981 and after consultation with the Post Office, hereby grants to the persons specified in paragraph 3 below a licence to do any of the acts and perform any of the services specified in paragraph 4 below (being acts and

services falling within the exclusive privilege of the Post Office of conveying letters as mentioned in section 66(1) of that Act), but subject to the conditions specified in paragraph 5 below and to the provisions as to revocation specified in paragraph 7 below.

2. For the purpose of this licence—

(1) "document exchange" means any premises on which facilities are provided—

(a) for the receipt of letters which—

(i) are to be conveyed from those premises and delivered to other premises on which similar facilities are provided, or

(ii) have been conveyed to and delivered at those premises from such other premises; and

(b) for the collection and taking delivery of such letters;

(2) "document exchange operator", in relation to premises on which such facilities are provided, means the person providing them, and, where they are provided by an unincorporated association of persons, any of those persons, and "operator" shall be construed accordingly;

(3) "member", in relation to a document exchange, means a person who has made written arrangements with the operator of that exchange for the use of any such facilities for a period of not less than three months beginning with the date on which the arrangements were made, and includes an unincorporated association of persons which has made such arrangements; and

(4) "person" includes an incorporated body.

3. The persons referred to in paragraph 1 above are—

(a) any document exchange operator;

(b) any employee of a document exchange operator; and

(c) any other person authorised by a document exchange operator to act on his behalf for the purpose of doing any of the acts or performing any of the services specified in paragraph 4 below.

4. The said acts and services are—

(a) the receipt of letters at, and their collection from, a document exchange; and

- (b) the conveyance of letters from one document exchange to another and their delivery at that other exchange.
5. Subject to paragraph 6 below, the said conditions are—
- (a) in relation to any letter received at a document exchange for the purposes of its delivery as mentioned in paragraph 2(1) (a) (i) above, that the sender of the letter is, at the time of its receipt there, either the operator of the exchange or a member of it;
- (b) in relation to any letter received at a document exchange having been delivered there as mentioned in paragraph 2(1) (a) (ii) above, that the addressee is, at the time of its receipt there, either the operator of the exchange or a member of it.
6. The said conditions shall not apply in relation to the receipt of a letter at a document exchange where—
- (a) the letter has been conveyed to and delivered at that exchange from another document exchange; and
- (b) the only purpose of its receipt at the second-mentioned exchange is for it to be conveyed from that exchange and delivered either—
- (i) to another document exchange of which the addressee of the letter is the operator or a member, or
- (ii) to one or more other document exchanges for the purpose of its ultimate delivery to a document exchange mentioned in sub-paragraph (i) above.
7. (1) Subject to paragraph (2) below, this licence shall cease to have effect:—
- (a) in respect of all persons to whom it applies, at the end of a period of one calendar month immediately following the last of the dates on which a notice to that effect, given by the Secretary of State, is published in the London, Edinburgh and Belfast Gazettes; and otherwise
- (b) in respect of any person to whom it applies who is given written notice to that effect by the Secretary of State, on the date specified for that purpose in the notice.
- (2) Before giving notice under paragraph (1) above, the Secretary of State shall:—
- (a) in the case of a notice under sub-paragraph (a), give to such persons as appear to him to represent the interests of document exchange operators and members of document exchanges, not less than 28 days written notification of his intention to give that notice; and
- (b) in the case of a notice under sub-paragraph (b), give to the document exchange operator concerned not less than 7 days written notification of his intention to give that notice, and shall take into account any representations with respect thereto made to him by any person within the said period of 28, or, as the case may be, 7 days.
8. Subject to paragraph 7 above, this licence shall continue in force from the date hereof until midnight on 31st December 2006.

DEPARTMENT OF HEALTH AND SOCIAL SERVICES

Notice is hereby given that the Department of Health and Social Services in exercise of the powers conferred on it by section 4, 7, 68 and 68A of the Food and Drugs Act (Northern Ireland) 1958 has made regulations entitled: Jam and Similar Products Regulations (Northern Ireland) 1982 (S.R. 1982 No. 105).

These regulations supersede the Food Standards (Preserves) Regulations (Northern Ireland) 1960. They come into operation on 1st August 1982 except for regulations 1, 2 and 20 which come into operation on 11th May 1982 and the provisions relating to labelling (regulations 5 and 7 to 10) which come into operation on 1st January 1983 (the day on which the Food Labelling Regulations (Northern Ireland) 1981 come fully into operation).

During 1982 food which complies with these regulations and the Food Labelling Regulations (Northern Ireland) 1981 will not be subject to the Food Standards (Preserves) Regulations (Northern Ireland) 1960 or the Labelling of Food Regulations (Northern Ireland) 1970, as amended, apart from the provisions of those regulations relating to claims.

The regulations implement in Northern Ireland Directive 79/693/EEC on the composition and labelling of jams, jellies, marmalade and chestnut purée.

The regulations lay down compositional and labelling requirements for two qualities of jam and jelly based on fruit content with the higher fruit content product being called extra jam or extra jelly. They also provide compositional standards for marmalade, chestnut purée, mince-meat and fruit curds and make provision for the first time for marketing a range of products with reduced sugar content.

THE INDUSTRIAL RELATIONS (N.I.) ORDER, 1982 No. 528 (NI 8)

This Order provides for payment out of public funds towards trade unions' expenditure in respect of ballots, for use of employers premises in connection with ballots and for the issue by the Department of Manpower Services of Codes of Practice for the improvement of industrial relations and makes provision in respect of the exclusion or expulsion from trade unions. The Order also amends the law in relation to unfair dismissal, maternity, guarantee payments, trade union membership and activities and wages councils and amends certain restrictions on legal liability in connection with a trade dispute.
