ORDER MADE BY THE TREASURY UNDER THE PROVISIONAL GOVERNMENT (TRANSFER OF FUNCTIONS) ORDER, 1922.

The Treasury in exercise of the powers vested in them by Article 5 of the Provisional Government (Transfer of Functions) Order, 1922, and of every other power enabling them in that behalf, hereby Order as follows:---

1. Parcels posted in Great Britain or the Isle of Man and sent to Ireland, or posted in Northern Ireland and sent to Great Britain or the Isle of Man, shall, for the purposes of the forms to be used, and the information to be furnished under the Post Office Acts, 1908 to 1920, and the Regulations made thereunder, be treated as foreign parcels, in Great Britain, the Isle of Man and Northern Ireland.

2. This Order shall come into operation on the first day of May, nineteen hundred and twenty-two.

RIALTAS SEALADACH NA HEIBEANN. (Irish Provisional Government). AGREEMENT AS TO DAY OF TRANSFER OF FUNCTIONS.

FOR the purposes of the Provisional Government (Transfer of Functions) Order, 1922, it is hereby agreed between the British Government and the Provisional Government that the first day of April, nineteen hundred and twenty-two shall be the day of transfer as respects the functions mentioned in Part I. of the Schedule to the said Order, except the functions of the Irish Land Commission (including the Public Trustee), the Clerk of the Crown and Hanaper, the Registry of Deeds, the Office of Woods and Forests, functions in relation to the Post Office Savings Bank and Trustee Savings Banks, functions of the Board of Trade in relation to lighthouses, buoys, and beacons, functions of the Paymaster-General in relation to services not transferred and the winding up of matters pending at the date of transfer, and the functions of any other existing department or authority relating to the functions above excepted.

WIRE NAILS, SNAP FASTENERS AND HOOKS AND EYES.

COMMITTEE. UNDER PART II OF THE SAFE-GUARDING OF INDUSTRIES ACT, 1921.

The Board of Trade give notice that they have received a complaint by the British Wire Nail Manufacturers' Association that Wire Nails manufactured in Germany are being sold or offered for sale in the United Kingdom at prices which, by reason of depreciation in the value in relation to sterling of the German currency, are below the prices at which similar goods can be profitably manufactured in the United Kingdom, and that by reason thereof employment in the wire nail industry in the United Kingdom is being or is likely to be seriously affected.

The Board of Trade have also received a complaint by the Pin, Hook and Eye and Snap Fastener Employers' Association that Hooks and Eyes manufactured in Germany, and Snap Fasteners manufactured in Germany and Czecho-Slovakia, are being sold or offered for sale in the United Kingdom at prices which, by reason of depreciation in the value in relation to sterling of the currencies of the abovenamed foreign countries respectively, are below the prices at which similar goods can be pro-fitably manufactured in the United Kingdom, and that by reason thereof employment in the industry manufacturing similar goods in the United Kingdom is being or is likely to be seriously affected. The Board of Trade, in seriously affected. exercise of the powers conferred upon them by Part II of the Safeguarding of Industries Act, 1921, have in the case of each of the abovementioned complaints referred the matter for inquiry to a Committee constituted for the purposes of that Part of the Act and consisting of :-

The Committee are directed, after ascertaining the facts, to report to the President of the Board of Trade (a) whether the conditions specified in Section 2, Sub-section (1) of the Safeguarding of Industries Act, 1921, are ful-filled; (b) on the effect which the imposition of a duty under Part II of the Act on goods of the classes or descriptions covered by the complaints would exert on employment in any other industries being industries using goods of those classes or descriptions as material; and (c) whether in the opinion of the Committee production in the industries manufacturing similar goods in the United Kingdom is being carried on with reasonable efficiency and economy.

The Committee propose to hold their first sitting for the taking of evidence at 5 Old Palace Yard, Westminster, London, S.W. 1, on Thursday, the fourth of May, 1922, at 2-30 p.m.

SUGAR CONFECTIONERY AND FOOD PRESERVING TRADE BOARD

(Northern Ireland).

The Trade Board established in Ireland under and in pursuance of the Trade Boards Act, 1909, for the Sugar Confectionery and Food Preserving Trade, having, as required by Regulations made by the Minister of Labour under Section 18 of the Trade Boards Act, 1909, dated 31st October, 1918, given due Notice on the 2nd day of December, 1921, of Proposal to Vary Minimum Rates of Wages;

The Trade Board established in Northern Ireland under the Powers vested in the Ministry of Labour for Northern Ireland, and in pursuance of Section 8 of the Government of Ireland Act, 1920, and the Enactments modified and adapted by the Government of Ireland (Adaptation of Enactments) (No. 3) Order, 1921, and any other Order of His Majesty in Council made under the said Act of 1920, for those branches of the Sugar Confectionery and Food Preserving Trade specified in the Regulations of the said Ministry, dated 2nd January, 1922, hereby give Notice that they have Varied Minimum Rates of Wages for Male and Female Workers.

The last-mentioned Trade Board have further given Notice that they have received notification that an Order was made by the Minister of Labour for Northern Ireland on the 29th March, 1922, confirming the said minimum rates as fixed by the Trade Board as aforementioned, and specifying the 20th day of April, 1922, as the date from which such Minimum Rates of Wages should become effective.

On request to the Trade Board particulars of the Minimum Rates and information as to their application will be given, if, /in the opinion of the Trade Board, the applicant is likely to be affected thereby.

WHEREAS by Section 9 of the Civil Authorities of Northern Ireland (Special Powers) Act, 1922, it is provided that the Minister of Home Affairs may by Order prohibit the holding of Inquests by Coroners on dead bodies in any area in Northern Ireland specified in such Order either absolutely or on such conditions as may be specified therein, and may provide for the duties of a Coroner and a Coroner's Jury or either of them as respects any Inquests so prohibited being performed by such Officer or Court as may be determined by the Order, and that such Officer or Court shall have and may exercise for the purpose of any Inquiry directed to be held in pursuance of such Order, or any report thereon all or any of the powers which might have been exercised by the Coroner or Coroner's Jury for the purposes of every inquest so prohibited and the finding thereon whether conferred by Statute or Common Law.

Now I, the Right Honourable Sir R. Dawson Bates, being the Minister of Home Affairs for Northern Ireland, do as from the date hereof by this Order prohibit the holding of Inquests by the Coroner on dead bodies within the area of the County Borough of Belfast, and do direct that the duties of the Coroner and Coroner's Jury as respects every inquest so prohibited shall be performed by means of an Inquiry to be held by James Graham, Esq., M.D., Coroner of the County Borough of Belfast, and do direct that the said James Graham shall have and may exercise for the purposes of every such Inquiry and his report thereon all and every of the powers whether conferred by Statute or Common Law which might have been exercised by the Coroner or Coroner's Jury for the purposes of every such Inquest so prohibited, and the finding thereon.. This Order shall continue in force until revoked.
