AMENDMENT REGULATIONS 1982

The Social Security Advisory. Committee give notice that they have been asked by the Secretary of State for Social Services under Section 10 of the Social Security Act 1980 to consider and report on the draft of regulations entitled The Social Security (Contributions) Amendment Regulations 1982.

A short explanatory note provided by the Department of Health and Social Security on these regulations is

appended to this notice. The Committee will take into account any comments or objections made by or on behalf of people or organizations who would be affected by the regulations received by them not later than 1st December 1982. #### · EXPLANATORY NOTE

These regulations seek to amend the Social Security (Contributions) Regulations 1979 in respect of company directors.

There have been difficulties in determining the appropriate "earnings periods" for directors in respect of their national insurance contribution liability because of their very wide variety of pay practices. This has led to anomalies in the amounts of contributions paid by directors.

These regulations apply to Great Britain only. Corresponding provision for Northern Ireland will be made in regulations made by the Department of Health and Social Services for Northern Ireland. The Northern Ireland regulations will not require separate submission to the Social Security Advisory Committee by virtue of paragraph 21 of Schedule 3 to the Social Security Act 1980 (1980 c.30).

The proposed regulations will give all company directors an annual earnings period, aligned with the tax year, or a pro-rata one if they are appointed part way through the year. This earnings period will apply to all earnings paid to the director by the company during the period (e.g. fees and, where appropriate, salary). They will also provide for directors' drawings in advance of fees being voted to be treated as earnings for contributions purposes; this will bring contributions arrangements into line with those for PAYE tax.
