the Post Office Inland Post Scheme 1979. The scheme, which will come into operation on 10th January 1983, provides for the raising of compensation limits for Datapost and express packets, the obtaining of a receipt on the delivery of a parcel, the extension of the Cash on Delivery service to Datapost packets, the extension of the Datapost service to Guernsey, alterations to the provisions in respect of articles for the blind, the refund of express delivery fees in the event of delay, and sundry minor alterations to conditions and procedures.

THE POST OFFICE INLAND POST AMENDMENT (No. 10) SCHEME 1983

Made 17th December 1982

Coming into operation 10th January 1983

The Post Office, by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969, and all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and citation

- (1) This Scheme shall come into operation on 10th January 1983 and may be cited as the Post Office Inland Post Amendment (No. 10) Scheme 1983.
- (2) This Scheme shall be read as one with the Post Office Inland Post Scheme 1979 (Post Office Scheme P1/1979) (hereinafter called "the Scheme") as amended by the Post Office Inland Post Amendment (No. 1) Scheme 1979 (Post Office Scheme P5/1979), the Post Office Inland Post Amendment (No. 2) Scheme 1980 (Post Office Scheme P1/1980), the Post Office Inland Post Amendment (No. 3) Scheme 1980 (Post Office Scheme P6/1980), the Post Office Inland Post Amendment (No. 4) Scheme 1981 (Post Office Scheme P1/1981), the Post Office Inland Post Amendment (No. 5) Scheme 1981 (Post Office Scheme P5/1981), the Post Office Inland Post Amendment (No. 6) Scheme 1981 (Post Office Scheme P11/1981), the Post Office Inland Post Amendment (No. 7) Scheme 1981 (Post Office Scheme P12/1981), the Post Office Inland Post Amendment (No. 8) Scheme 1981 (Post Office Scheme P15/1981) and the Post Office Inland Post Amendment (No. 9) Scheme 1982 (Post Office Scheme P1/1982).

Interpretation

- (1) In sub-paragraph (1) of paragraph 3 of the Scheme, in the definition of "cash on delivery packet",

POST OFFICE SCHEME P1/1983

NOTE: The Scheme which follows this note has been made under Section 28 of the Post Office Act 1969 and amends

after the words "a registered letter," and before the words "a registered newspaper" there shall be inserted the words "a Datapost packet."

(2) In sub-paragraph (1) of paragraph 3 of the Scheme, in the definition of "postal packet", the words "except a telegram" shall be deleted.

Prohibitions

3. The following sub-paragraph shall be inserted after sub-paragraph (2) (f) of paragraph 8 of the Scheme:

"(g) Whereon the payment of any postage or fees is denoted by an adhesive stamp or stamps, and where the stamp or stamps have not been securely affixed in such manner as the Post Office may require."

Return of undeliverable parcels

4. In sub-paragraph (3) of paragraph 17 of the Scheme the words "a period of 3 months beginning with the day when it was opened and examined" shall be deleted and the words "such time as the Post Office shall think fit" inserted in their place.

Conditions as to current registered newspapers

5. Sub-paragraph (1) of paragraph 22 of the Scheme shall be deleted.

Parcels

6. The following sub-paragraphs shall be inserted after sub-paragraph (2) of paragraph 23 of the Scheme:

"(3) The sender of a parcel shall attach to the parcel such label in such position, as the Post Office may require.

(4) On the delivery of a parcel the recipient shall, where the Post Office so requires, give a written receipt therefor in the prescribed form. Where such a receipt is not obtained, the packet may nevertheless be delivered, or may be withheld and dealt with or disposed of in such manner as the Post Office may think fit."

Articles for the blind

7. Paragraph 24 of the Scheme shall be deleted and the following inserted in its place:

"Articles for the blind"

24. (1) In this Scheme the expression "articles for the blind" means:

(i) Books, papers and letters to or from blind persons, impressed or otherwise prepared for use by the blind.

(ii) Paper sent to any person for impressing or otherwise preparing for that purpose.

and the following articles specially adapted for the use of the blind:

(iii) Relief maps.

(iv) Machines, frames and attachments for making impressions for use by the blind.

(v) Writing frames and attachments.

(vi) Braillette boards and pegs.

(vii) De Braille instructional devices.

and the following articles which may be sent only to blind persons by organisations or institutions which have entered into special arrangements with the Post Office for sending these articles, or to such organisations by blind persons:

(viii) Games (including card games).

(ix) Mathematical appliances and attachments.

(x) "Talking Books" and "Talking Newspapers", that is to say voice recordings on magnetic tape, disc, film or wire of either:

(a) readings from printed books, journals, newspapers, periodicals or similar publications; or

(b) material which, although not necessarily printed, is of the nature of a book, journal, newspaper or similar publication and is not of the nature of a general entertainment programme;

and apparatus designed to play such recordings.

(xi) Metal plates impressed, or sent for impressing, for use by the blind.

(xii) Supplies of wrappers, envelopes and labels for sending articles for use by the blind.

(xiii) Watches, clocks, timers, tools, aids, precision instruments, rules and measures designed for use by the blind.

(xiv) Sectional or collapsible walking sticks.

(xv) Harness for guide dogs.

(2) The following provisions shall apply to postal packets consisting of articles for the blind:

(a) Every packet shall bear on the outside thereof the inscription "Articles for the Blind" and the written or printed name and address of the sender.

(b) Except as the Post Office may either generally or in any particular case allow, every packet shall be subject to examination in the post, and every packet shall be posted either without a cover or in a cover which can be easily removed for the purposes of examination.

(c) No packet shall contain any article which is not an article for the blind (except a label which may bear the name and address of the person to whom the packet is to be returned).

(d) No packet shall contain any communication or inscription either in writing or printing (except the title, date of publication or manufacture, serial number, names and addresses of printer, publisher or manufacturer, price and table of contents of the book or paper, and any key to or instructions for the use of the special type or of any enclosed article)."

Express delivery

8. The following sub-paragraph shall be inserted after sub-paragraph (6) of paragraph 28 of the Scheme:

"(7) In the event that an express packet is not available for delivery at the place of address on the same day as it was posted, where such a facility is provided, the fee paid under (1) above may be refunded to the sender of the packet at the discretion of the Post Office."

Compensation for certain other postal packets

9. In sub-paragraph (3) of paragraph 47 of the Scheme, after the words "ordinary packet" and before the words "and its contents" there shall be inserted the following: "(except a Datapost packet or an express packet)". After the figures "£16.50." there shall be added the words "In the case of a Datapost packet or an express packet, the maximum amount shall be £100."

Cash on delivery

10. In sub-paragraph (2) of paragraph 48 of the Scheme, after the words "(other than" and before the word "parcels)" there shall be inserted the words "Datapost packets and".

Services not available for packets to and from the Channel Islands, Isle of Man or the Republic of Ireland

11. In paragraph 58 of the Scheme, after the words "Republic of Ireland" there shall be inserted the following: "except that the Datapost service shall be available for packets posted for transmission between the British postal area and Guernsey".

Compensation for certain postal packets to and from the Channel Islands, the Isle of Man and the Republic of Ireland

12. In paragraph 67 of the Scheme, after the words "the Post Office may" and before the words "pay compensation" there shall be inserted the following: "(except as hereafter provided)". After the words "administrations of these Islands or the Republic.", there shall be added the words "In the case of a Datapost packet posted for transmission between the British postal area and Guernsey, the maximum amount of compensation which shall be payable shall be £16.50."

Postage not prepaid or insufficiently prepaid

13. In paragraph 69 of the Scheme the words "an amount equal to twice the amount of the postage, or as the case may be, of the deficiency." shall be deleted and the words "such amount as the Post Office may from time to time determine." inserted in their place.

Datapost service

14. In sub-paragraph (7) of paragraph 75 of the Scheme the words and figures "43, Part X and Part XIV" shall be deleted and the word and figures "and 43" inserted in their place.

Postal facilities

15. Items 4 and 5 of Schedule 3 to the Scheme as subsequently amended shall be deleted and the following inserted in their place:

"4. Advice of delivery of, or inability to deliver, a registered, recorded delivery or Datapost packet or a parcel:

- (a) if requested at time of posting ... 22½p
- (b) if requested subsequent to posting ... 45p"

Dunbarton Burn (Additional Works)

The Department of Agriculture for Northern Ireland hereby gives notice in pursuance of Article 12(1)(b) and 12(2) of the Drainage (Northern Ireland) Order 1973 that a Scheme has been prepared for the better drainage of: that part of the Dunbarton Burn which flows through the townland of Ballymacanallen in the County of Down which the Drainage Council have determined to be a designated watercourse within the meaning of Article 3(4)(a) of the Drainage (Northern Ireland) Order 1973.

A copy of the Scheme may be inspected free of charge by any person during the period 17th January, 1983 to 17th February, 1983 inclusive at the offices of Banbridge District Council, Civic Buildings, Downshire Road, Banbridge, Co. Down, at any reasonable time.

Any person who considers that his interests will be prejudicially affected by the Scheme may, at any time within one month after the date of publication of this notice send to the Secretary, Department of Agriculture, Drainage Division, 157 Hillsborough Road, Lisburn BT27 5PX, all such observations in regard to the Scheme as he shall think proper.

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by Article 50(4) of the Road Traffic (Northern Ireland) Order 1981 and of all other enabling powers made on 16th December, 1982 an Order entitled Roads (Speed Limit) (No. 7) Order (Northern Ireland) 1982 (S.R. 1982 No. 416) which will come into operation on 5th January, 1983.

The effect of the Order is to reduce the length of the Old Dundonald Road to which a 40 miles per hour speed

limit applies, thus increasing the length to which a 30 miles per hour speed limit applies.

This Order revokes and replaces the Roads (Speed Limit) (No. 6) Order (Northern Ireland) 1982.

The Department hereby gives notice of its intention to make an Order under Article 40 of the Roads (Northern Ireland) Order 1980 the effect of which would be to abandon a length of approximately 90 metres of Henry Street extending in a north-westerly direction from its junction with Corporation Street in the City of Belfast.

The length of road proposed to be abandoned is delineated on a map which, together with a copy of the draft Order, may be inspected free of charge at all reasonable hours during the period from 7th January, 1983 to 16th February, 1983 at the Department's Roads Service Headquarters, Room 215, Commonwealth House, 35 Castle Street, Belfast BT1 1GU and the Department's Development Office, Clarendon House, 9/21 Adelaide Street, Belfast.

Any person may within the said period object to the proposal by written notice to Roads Service Headquarters at the above address stating the grounds of objection.

A proposal for the following Order in Council has been published and is available in HMSO price £5.10.

DRAFT HOUSING (NORTHERN IRELAND) ORDER

This Order amends the law relating to housing in Northern Ireland.

Part I is introductory. Part II provides security of tenure and other rights for certain tenants of the Northern Ireland Housing Executive and of registered housing associations and gives certain secure tenants of the Executive the right to buy their homes. In Part III fresh provision is made for payment by the Executive of grants for carrying out works of improvement, repair and conversion to houses.

Part IV amends certain provisions of the Housing (Northern Ireland) Order 1981 which relate to houses in multiple occupation, registered housing associations and other miscellaneous matters. Part V provides for the creation of protected shorthold tenancies and amends the Rent (Northern Ireland) Order 1978. Part VI is supplementary.

THE DRAFT LICENSING (INTERNATIONAL AIRPORTS) (N.I.) ORDER

This Order will exempt specified licensed premises on certain international airports from sections 28 and 41 of the Licensing Act (Northern Ireland) 1971. It will allow

international travellers in airports in Northern Ireland, complying with certain conditions, to be supplied at any time with intoxicating liquor for consumption on the premises, i.e. in the international lounge, or in the case of a duty free shop, to be consumed outside the country. It will be possible to buy other duty-free goods in the duty-free shop.
