DEPARTMENT OF AGRICULTURE

THE FEEDING STUFFS (AMENDMENT)

REGULATIONS (NORTHERN IRELAND) 1984

Notice is hereby given that the Department of Agriculture for Northern Ireland, in exercise of the powers conferred on it by Section 66(1), 68(1) and (1A) and (3), 69(1), and (3), 70(1), 73(3), 74(1), 74A and 84 of the Agriculture Act 1970 and of every other power enabling it in that behalf, has made on 1st February, 1984 the Feeding Stuffs (Amendment) Regulations (Northern Ireland) 1984 (SR 1984 No. 27).

The Regulations will come into operation in part on 31st July 1984 and will be fully operative by 1st July 1985.

These Regulations amend the Feeding Stuffs Regulations (Northern Ireland) 1982 by implementing various EC Directives.

The principal amendments effect:

- (a) the restriction of descriptions of categories of ingredients used in labelling pet foods to those specified in a new Schedule 6, (regulation 5);
- (b) provision for the control of certain protein sources and non-protein nitrogenous compounds specified in a new Schedule 7, (regulation 8);
- (c) modifications to the detailed requirements of Schedule 1 as to statutory statements (regulation 10);
- (d) modifications to the specifications provided in Schedule 2 for materials used in feeding stuffs, (regulation 11);
- (e) modifications to the provisions of Schedule 4 as to permitted colourants and other additives in feeding stuffs, (regulation 13); and
- (f) modifications to the provisions of Schedule 5 as to undesirable substances in feeding stuffs (regulation 14).

In addition to the amendments implementing the Directives named above, there are amendments to the definitions in regulation 2(1) of the principal regulations, to regulation 6 and 8 of the principal regulations concerning statutory statements, to regulation 14(1) of the principal regulations concerning substances having a similar affect to that of vitamins or pro vitamins and to regulation 19 of the principal regulations concerning feeding stuffs used in the experimental testing of substances controlled under regulation 14 for purposes of scientific research.

Similar Regulations have been made in Great Britain.

The Department of the Environment has made a Statutory Rule entitled the Road Transport Licensing (Authorisation of International Journeys) (Fees) Regulations (Northern Ireland) 1984 — S.R. 1984 No. 32.

This Rule, which comes into operation on 1st April, 1984, increases the fees for period permits (permits allowing Northern Ireland road freight operators to carry

goods for reward from Northern Ireland to the Republic of Ireland and from the Republic of Ireland to Northern Ireland) as follows:

- (a) from £30 to £39 for a permit which is valid for one year; and
- (b) from £2.50 to £3.25 for each month, or part thereof for a permit which is valid for less than one year.

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by Section 6 of the Down County Council (Strangford Lough Ferry) Act (Northern Ireland) 1967 and of all other enabling powers made on 7th February, 1984, an Order entitled The Strangford Lough Ferry (Maximum Charges) Order (Northern Ireland) 1984 (S.R. 1984 No. 33) which will come into operation on 31st March, 1984.
