# WEIGHTS AND MEASURES (NORTHERN IRELAND) **ORDER 1981**

The Department of Economic Development has made Regulations under the Weights and Measures (Northern Ireland) Order 1981 entitled: "Weighing Equipment (Beltweighers) Regulations (Northern Ireland) 1985" (SR 1985 No. 319).

These Regulations, which come into operation on 20th December, 1985, amend the Weights and Measures Regulations (Northern Ireland) 1967 (SR & O (N.I.) 1967 No. 237) to provide that the latter Regulations shall no longer apply to the majority of beltweighers. The new Regulations being the metrological requirements for such weighing equipment into line with new technology and with the provisions of EC Directives relating to beltweighers.

The Regulations provide for the purpose for which beltweighers may be used for trade, the materials and principles of construction of beltweighers, their manner of erection and use for trade and their testing, passing as fit for use for trade and stamping by an inspector of weights and measures and for the obliteration of such stamps. The Regulations also prescribe limits of error for beltweighers.
