A PROCLAMATION

DETERMINING THE SPECIFICATIONS AND DESIGN FOR TWO POUND COINS COMMEMORATING THE XIII COMMONWEALTH GAMES, TO BE HELD IN SCOTLAND, AND PROVIDING FOR RELATED MATTERS

ELIZABETH R.

Whereas under section 3(1)(a), (b), (cc), (d), (dd), (f) and (ff) of the Coinage Act 1971 We have power, with the advice of Our Privy Council, by Proclamation to determine the denomination, design, dimensions, weight and composition of coins to be made at Our Mint, to determine the remedy to be allowed in the making of such coins and the percentage of impurities which they may contain, and to direct that such coins, other than those of gold, silver, cupro-nickel and bronze, shall be current and be legal tender for payment of any amount:

And Whereas under section 6(2) of the Coinage Act 1971 We have power, by Proclamation, to prescribe the composition of the standard trial plates to be used for determining the justness of coins issued from Our Mint of any metal or mixture of metals other than gold, silver and cupro-nickel:

And Whereas it appears to Us desirable to order that, to commemorate the XIII Commonwealth Games, to be held in Scotland in the year One thousand nine hundred and eighty-six, there should be made at Our Mint in gold, in silver and in nickel brass a coin of the denomination of two pounds.

We therefore, in pursuance of the said section 3(1)(a), (b), (cc), (d), (dd), (f) and (ff) and the said section 6(2) and of all other powers enabling Us in that behalf, do hereby, by and with the advice of Our Privy Council, proclaim, direct and ordain as follows:—

The Gold Coin

1. (1) A new coin of gold of the denomination of two pounds shall be made, being a coin of a standard diameter of 28.4 millimetres, and circular in shape.

(2) The design for the said gold coin shall be as follows:—

For the obverse impression Our effigy with the inscription "ELIZABETH · II · DEI · GRATIA · REGINA · F · D" and the words "TWO POUNDS", and for the

reverse a St. Andrew's cross surmounted in chief by a crown triumphal overall a Thistle of Scotland and the date of the year "1986". The coin shall have a graining upon the edge.

The Silver Coins

2. (1) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight of 15.976 grammes, a standard diameter of 28.4 millimetres, and a standard composition of one half fine silver and one half alloy; or millesimal fineness 500, and being circular in shape.

(2) In the making of the said silver coin a remedy (that is, a variation from the standard weight, diameter or composition specified in subsection (1) above) shall be allowed of an amount not exceeding the following, that is to say:—

- (a) a variation from the standard weight of an amount per coin (measured as the average of a sample of not more than one kilogramme of the coin) of 0.095 grammes;
- (b) a variation from the standard diameter of 0.1 millimetres per coin; and
- (c) a variation from the said standard composition of ten per mille.

(3) A new coin of silver of the denomination of two pounds shall be made, being a coin of a standard weight of 15.976 grammes, a standard diameter of 28.4 millimetres, and a standard composition of thirty-seven-fortieths fine silver and three-fortieths alloy; or millesimal fineness 925, and being circular in shape.

(4) In the making of the said silver coin a remedy (that is, a variation from the standard weight, diameter or composition specified in subsection (3) above) shall be allowed of an amount not exceeding the following, that is to say:—

- (a) a variation from the said standard weight of an amount per coin (measured as the average of a sample of not more than one kilogramme of the coin) of 0.095 grammes;
- (b) a variation from the said standard diameter of 0.1 millimetres per coin and
- (c) a variation from the said standard composition of five per mille.

The Nickel Brass Coin

3. (1) A new coin of nickel brass of the denomination of two pounds shall be made, being a coin of a standard weight of 15.976 grammes, a standard diameter of 28.4 millimetres, and a standard composition of seventy per centum copper, five and one half per centum nickel and twenty-four and one half per centum zinc, and being circular in shape.

(2) In the making of the said nickel brass coin a remedy (that is, a variation from the standard weight, diameter or composition specified in subsection (1) above) shall be allowed of an amount not exceeding the following, that is to say:—

- (a) a variation from the said standard weight of an amount per coin (measured as the average of a sample of not more than one kilogramme of the coin) of 0.095 grammes.
- (b) a variation from the said standard diameter of 0.1 millimetres per coin; and
- (c) a variation from the said standard composition of two per centum copper, three quarters per centum nickel and two per centum zinc.

(3) The said coin may contain impurities of 0.75 of one per centum.

(4) The said coin shall be current and be legal tender for payment of any amount in any part of Our United Kingdom.

(5) The composition of the standard trial plates to be used for determining the justness of the said nickel brass coin shall be pure copper, pure nickel and pure zinc.

Design for The Silver and Nickel Brass Coins

4. The design for the said silver and nickel brass coins shall be as follows:—

For the obverse impression Our effigy with the inscription "ELIZABETH. II. DEI. GRATIA. REGINA. F.D." and the words "TWO POUNDS", and for the reverse a St. Andrew's cross surmounted in chief by a crown triumphal overall a Thistle of Scotland and the date of the year "1986". The coins shall have a graining upon the edge and in incuse letters the inscription "XIII COMMONWEALTH GAMES SCOTLAND 1986", after which there shall be placed the mark of Our Mint in Llantrisant.

5. This Proclamation shall come into force on the nineteenth day of December One thousand nine hundred and eighty-five.

Given at Our Court at Buckingham Palace, this eighteenth day of December in the year of our Lord One Thousand nine hundred and eighty-five and in the thirty-fourth year of Our Reign.

For the purpose of revaluing on repayment Index-Linked National Savings Certificates (Retirement Issue and 2nd Index-Linked Issue) and contributions under Save As You Earn savings contracts (Third Issue) in accordance with the relevant prospectuses, the Index figure issued by the Department of Employment in the month of December, 1985 and applicable to the month of January, 1986 is 378.4.

DEPARTMENT OF AGRICULTURE

Notice is hereby given that the Department of Agriculture for Northern Ireland in exercise of the powers conferred on it by 6 Section 2 (2) of the European Communities Act 1972 and of all other powers enabling it in that behalf has made Regulations entitled the Calf Premium (Protection of Payments) (No. 2) Regulations (Northern Ireland) 1985 (1985 S.R. No. 352).

Council Regulation (EEC) No. 1310/85 enables the payment of Premiums for calves which are born in Northern Ireland on or after 27th May, 1985 and before 7th April, 1986 which are reared in Northern Ireland to six months of age. The Commission Regulation (EEC) No. 1638/85 lays down more detailed rules for the granting of the Premium. Copies of these Regulations are available for inspection at the Department's County Agricultural Executive Offices.

The present Regulations make provision for the implementation of the Council and Commission Regulations in Northern Ireland. They identify the competent authority referred to in the Commission Regulation and those responsible for administering that Regulation and make more specific the conditions for eligibility for Premium. They place certain duties on the applicant in relation to the handling and presentation of calves which are to be assessed for eligibility for Premium and of the Department's appointment officer to mark the calves when eligibility has been established. They also permit authorised persons acting on behalf of the Department to enter forms, inspect and count cattle kept there and to inspect relevant documents for the purpose of ensuring that the Premium is only paid in appropriate circumstances. Finally, the Regulations empower the Department to recover Premium paid in certain circumstances and create offences, relating to the making of false statements or obstructing the persons exercising the powers or entry, which are punishable on summary conviction by a fine not exceeding £400.

WIRELESS TELEGRAPHY ACT 1949
