£4% (INCOME TAX COMPOUNDED) WAR LOAN, 1929-42.

The Lords Commissioners of His Majesty's Treasury in exercise of the option reserved to Them in the Prospectus dated 11th January, 1917, hereby give notice to Holders of the above Loan that the said Loan will be repaid at par on the 15th January, 1931, together with 3 months' interest to that date. Interest on the Loan will then cease.

A communication regarding the repayment will in due course be sent by the Bank of England to Holders of Stock inscribed or registered at the Bank of England, and by the Bank of Ireland to Holders of Stock inscribed or registered at the Bank of Ireland: in the case of Joint Accounts the relative Form or Request for payment of the Redemption Money will be sent to the first Holder.

Bearer Bonds, together with all unmatured coupons should be lodged at the Bank of England Loans Office, 5 and 6 Lombard Street, London, E.C.3, three clear days before the date fixed for repayment of the Bonds.
