CIVIL AUTHORITIES (SPECIAL POWERS) ACT (NORTHERN IRELAND), 1922.

WHEREAS by Regulation 18a of the Regulations made under and pursuant to the said Act, it is provided that where any house or other premises is or has been used for any purpose prejudicial to the preservation of the Peace and maintenance of Order, the Civil Authority may by Order require every person residing in or occupying such house or other premises forthwith to vacate the same, and may further order and require such house or other premises to be closed altogether.

And whereas the house and premises herein-after mentioned have been so used for such purposes as aforesaid.

Now I, the Right Honourable Sir R. Dawson Bates, Minister of Home Affairs for Northern Ireland, being the Civil Authority under the said Act, by virtue of the powers conferred on me by the said Act and the Regulations made thereunder and of every other power thereunto me enabling, do hereby order and require all persons residing in or occupying the house and premises known as The Duncairn Arms Hotel, 135 Antrim Road, in the County of the City of Belfast, forthwith to vacate the same, and that the said house and premises be closed altogether, and do further Order that all such steps as may be necessary for that purpose be forthwith taken to enforce compliance with this Order.

RATES OF INTEREST ON LOCAL LOANS.
