NATIONAL HEALTH INSURANCE ACTS, 1924 to 1930.

NOTICE is hereby given under the Rules Publication Act, 1893, that it is proposed by the National Health Insurance Joint Committee, the Minister of Health, the Department of Health for Scotland, and the Ministry of Labour for Northern Ireland, acting jointly so far as regards Regulations which the said Joint Committee are empowered to make jointly with any of the persons or bodies afore-said, and acting separately so far as regards Regulations which the said Joint Committee or any of the said persons or bodies are empowered to make alone, after the expiration of at least

40 days from this date, in exercise of the powers conferred upon them by the National Health Insurance Acts, 1924 to 1930, to make Regulations to be entitled the National Health
