TRADE BOARDS ACT (NORTHERN IRELAND), 1923.

ROPE, TWINE, AND NET TRADE BOARD (NORTHERN IRELAND).

The Trade Board established by the Ministry of Labour for Northern Ireland under the powers conferred by the Trade Boards Act (Northern Ireland), 1923, for the Rope, Twine, and Net Trade in Northern Ireland as defined in the Schedule to the Trade Boards (Rope, Twine, and Net Trade, Northern Ireland) (Constitution, Proceedings and Meetings)

Regulations, 1926, dated 23rd March, 1926, hereby give notice that they propose to vary certain minimum rates of wages for male workers.

On request to the Trade Board particulars of the proposed variation of minimum rates and information as to their application will be given if, in the opinion of the Trade Board, the applicant is likely to be affected thereby.

The Trade Board will consider any objections to their proposals, which may be lodged with them within fourteen days from the twenty-seventh day of April, 1931. Such objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Rope, Twine, and Net Trade Board (Northern Ireland), Office of Trade Boards, Ormeau Avenue, Belfast. It is desirable that persons making objections should state, as far as possible, the precise grounds for their objections.
