NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Article 13 of the Magistrates' Courts (Northern Ireland) Order 1981 has made a Statutory Rule entitled the Magistrates' Courts (Great Britain Driving Licence Appeals) Rules (Northern Ireland) 1991.

POST OFFICE SCHEME OP1/1991

NOTE: The Scheme which follows this Note has been made under Section 28 of the Post Office Act 1969, and amends the Post Office Overseas Parcel Post Scheme 1982. The Scheme, which comes into operation on 2nd April 1991, revises the charges applicable to parcels to all countries and certain other fees, increases compensation levels and withdraws the outward insured parcel service.

The Post Office, by virtue of the powers conferred upon it by Section 28 of the Post Office Act 1969 and of all other powers enabling it in this behalf, hereby makes the following Scheme:

Commencement and citation

 --(1) This Scheme shall come into operation on 2nd April 1991 and may be cited as the Post Office Overseas Parcel Post Amendment (No. 13) Scheme 1991.

(2) This Scheme shall be read as one with the Post Office Overseas Parcel Post Scheme 1982 (Post Office Scheme P3/1982) (hereinafter called "the Scheme") as amended by the Post Office Overseas Parcel Post Amendment (No. 1) the Post Office Overseas Parcel Post Amendment (No. 1) Scheme 1983 (Post Office Scheme P2/1983), the Post Office Overseas Parcel Post Amendment (No. 2) Scheme 1984 (Post Office Scheme 4/1984), the Post Office Overseas Parcel Post Amendment (No. 3) Scheme 1985 (Post Office Scheme 3/1985), the Post Office Overseas Parcel Post Amendment (No. 4) Scheme 1985 (Post Office Scheme 5/1985), the Post Office Overseas Parcel Post Amendment (No. 5) Scheme 1986 (Post Office Scheme 1/1986), the Post Office Overseas Parcel Post Amendment (No. 6) Scheme 1986 (Post Office Scheme 3/1986), the Post Office Overseas Parcel Post Amendment (No. 7) Scheme 1986 (Post Office Scheme 7/1986), the Post Office Overseas Parcel Post Amendment (No. 8) Scheme 1987 (Post Office Scheme 1/1987) the Post Office Overseas Parcel Post 1/1987), the Post Office Overseas Parcel Post Amendment (No. 9) Scheme 1987 (Post Office Scheme 3/1987), the Post Office Overseas Parcel Post Amendment (No. 10) Scheme 1988 (Post Office Scheme 1/1988), the Post Office Overseas Parcel Post Amendment (No. 11) Scheme 1989 (Post Office Scheme OP1/1989), and the Post Office Overseas Parcel Post Amendment (No. 12) Scheme 1990 (Post Office Scheme OP1/1990).

Fees for customs clearance

2. In paragraph 9 of the Scheme as subsequently amended, $\pounds 2.80$ " shall read " $\pounds 3.50$ ".

Express delivery

- 3. In paragraph 20 of the Scheme as subsequently amended:
 - (a) the words "Standard Service" shall be inserted immediately after the word "outgoing";
 - (b) "£2.10" shall read "£2.50".

Cash on delivery parcels

4. In sub-paragraph (3) (a) of paragraph 21 of the Scheme as subsequently amended, "80p" shall read "£1.20".

Delivery free of charges

5. In sub-paragraph (1) (b) of paragraph 22 of the Scheme as subsequently amended, "£1.00" shall read "£1.20".

Insured parcels and uninsured parcels containing valuables 6. Sub-paragraphs (1) and (2) of paragraph 23 of the Scheme shall be deleted.

Compensation

 - (a) sub-paragraphs 2(a) and 2(b) shall be deleted and the following inserted in their place:
 - "(a) any one outgoing Standard Service parcel and its contents shall not in any case exceed £250;
 - (b) any one outgoing Economy Service parcel and its contents, or any one incoming uninsured parcel and its contents shall not in any case exceed £100. Such payment shall be according to the scale set out in Schedule 3, having regard to the weight of the parcel;"
 - (b) sub-paragraph (4) shall be deleted;
 - (c) In sub-paragraph (5), the words "and, in the case of an outgoing insured parcel, paragraph 23(1)" shall be deleted;
 - (d) In sub-paragraph (6), the words "and in the case of an insured parcel a fresh insurance fee, where possible," shall be deleted;
 - (e) Sub-paragraph (8)(a) shall be deleted and the following inserted in its place:
 - "(a) a claim for such compensation is received:
 - (i) in the case of an outgoing parcel, from the sender within a period of 4 months, or from the addressee within a period of 12 months, both periods beginning with the date on which the parcel was posted; or
 - (ii) in the case of an incoming parcel, from the sender or the addressee within a period of 12 months beginning with the date on which the parcel was posted;"

Movement of The United Kingdom General Index of Retail Prices

For the purposes of revaluing on repayment Index-linked National Savings Certificates (Retirement Issue, 2nd, 3rd, 4th and 5th Index-linked Issues) and contributions under Save As You Earn savings contracts (Third Issue) and for revising the annual rate of interest for Indexed-Income Bonds, the Index figure issued by the Central Statistical Office in the month of March and applicable to the month of April is 130.9. This figure is based on the revised reference base of 100 adopted in January 1987. In accordance with the relevant prospectuses a notional Index figure of 516.4 has been calculated and will apply to Index-linked Savings Certificates and Indexed-Income Bonds purchased in March 1987 or earlier and SAYE contributions which were due for payment and made in February 1987 or earlier.

Thirty-sixth Issue

The Department of Finance and Personnel has made a Direction stating the terms of a new Thirty-sixth Issue of Ulster Savings Certificates.

The Thirty-fifth Issue of Ulster Savings Certificates was withdrawn from sale on 14th March, 1991.

Certificates of the new Thirty-sixth Issue will be issued on or after 2nd April 1991 with a basic unit of £25 which will earn compound interest at a rate of 8.50% per annum guaranteed over 5 years.

There will be a maximum holding of £5,000 (200 units) irrespective of any holding of any other issue with special facilities for an additional holding of up to £10,000 (400 units) for holders who are reinvesting into this Issue from their existing matured Certificates.

Repayment of a certificate within a year of purchase will be at the purchase price only, except in the case of reinvestment certificates which will earn interest at three monthly intervals at a rate of 5.50% per annum.

FIFTH INDEX-LINKED ISSUE

The maximum normal holding for the existing Fifth Index-Linked Issue Ulster Savings Certificates has been increased from £5,000 to £10,000 (400 units) with effect from 21st March 1991. There is no change in the reinvestment holding limit of £10,000 (400 units).

THE COLERAINE-LONDONDERRY TRUNK ROAD T7 LIMAVADY BY-PASS

The Department of the Environment for Northern Ireland hereby gives notice in accordance with the provisions of Schedule 6 to the Roads (Northern Ireland) Order 1980 that it proposes to make an Order under Articles 13 and 40 of the Order.

The proposed order will:

- provide that approximately 3.5 kilometres of a proposed new road in the townlands of Rascahan, Lisnakilly, Newtown Limavady, Killane and Rathbrady More, County of Londonderry from the junction of Ballykelly Road and Farlow Road extending in a north-easterly direction to McKays Plantation, Killane and thence in a south-easterly direction to join the Broad Road approximately 150 metres east of its junction with Scriggan Road and Rathmore Road including 2 new roundabouts shall become part of the Trunk Road T7;

CASTLEREAGH No. 6, 7, 8, 9, 10 and 11 SMOKE CONTROL ORDERS (NORTHERN IRELAND) 1991

- 1.
