### NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Article 359 of the Insolvency (Northern Ireland) Order 1989 and Section 19 of the Registration of Deeds Act (Northern Ireland) 1970 has made a Statutory Rule entitled the Insolvency Rules (Northern Ireland) 1991.

These rules, which come into operation on 1st October, 1991, set out the detailed procedure for the conduct of all company and individuals insolvency proceedings under the Insolvency (Northern Ireland) Order 1989 and otherwise give effect to that Order. The insolvency proceedings concerned are:

- company voluntary arrangements (Part 1 of the Rules),
- administration (Part 2),
- appointment of receiver or manager; administrative receivership (Part 3),
- companies winding up (Part 4),
- individual voluntary arrangements (Part 5), and
- bankruptcy (Part 6).

Parts 7 to 12 of the Rules apply to both company and individual insolvency proceedings and are concerned with the following matters:

- court procedure and practice (Part 7),
- proxies and company representation (Part 8),
- examination of persons concerned in company and individual insolvency (Part 9),
- official receivers (Part 10),
- declaration and payment of dividend (winding up and bankruptcy) (Part 11), and
- miscellaneous and general (Part 12).

The Arrangement of Rules at the beginning of these Rules lists the numbers and contents of all the Rules and Schedules. The Rules come into operation on the day appointed for the coming into operation of Article 359 of the Insolvency (Northern Ireland) Order 1989 and generally apply to all insolvency proceedings commenced on or after that date. The Rules also apply to such proceedings commenced before that date to which provisions of the Insolvency (Northern Ireland) Order 1989 are applied by Schedule 8 to that Order to the extent necessary to give effect to those provisions. In addition, Rules 6.033-CP, 7.30 and 7.31 expressly provide for their application to insolvency proceedings, whenever commenced.

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Article 365 of the Insolvency (Northern Ireland) Order 1989 has made a Statutory Rule entitled the Administration of Insolvent Estates of Deceased Persons Order (Northern Ireland) 1991.

This Order, which comes into operation on 1st October, 1991, specifies the provisions of the Land Registration Act (Northern Ireland) 1970, the Registration of Deeds Act (Northern Ireland) 1970, the Judgments Enforcement (Northern Ireland) Order 1981 and the Insolvency (Northern Ireland) Order 1989 which apply to the administration in bankruptcy of the insolvent estates of deceased persons and the modifications to those provisions.

It also specifies the provision which apply where the estate of a deceased person is insolvent and is administered otherwise than in bankruptcy and which replace the provisions of section 30(1) of and Part 1 of the First Schedule to the Administration of Estates Act (Northern Ireland) Order 1989 (N.I.19).

Where a debtor by or against whom a bankruptcy petition has been presented dies the proceedings in the matter are unless the court otherwise orders continued as if he were alive but with the modifications in Schedule 2.

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Article 364 of the Insolvency (Northern Ireland) Order 1989 and Article 24(1) of the Companies (Northern Ireland) Order 1989 has made a Statutory Rule entitled the Insolvent Partnerships Order (Northern Ireland) 1991.

This Order which comes into operation on 1st October, 1991, specifies the provisions of the Insolvency (Northern Ireland) Order 1989 ("the Insolvency Order") which apply to insolvent partnerships and the modifications to certain of those provisions. This Order only applies where an insolvent partnership is being wound up and does not affect the winding up of corporate partners and the bankruptcy of individual partners under the Insolvency Order in the normal manner. This Order also applies certain provisions of the Companies (Northern Ireland) Order 1989.

This Order makes the following provisions:

1. An insolvent partnership may be wound up under Part VI of the Insolvency Order as an unregistered company without the insolvency of the Order as an unregistered company without the insolvency of the partners. The provisions of Part VI of the

Insolvency Order that apply with relevant modifications are specified in Schedule 1 to this Order. These include Article 185(1), which applies all the provisions of the Insolvency Order and the Companies (Northern Ireland) Order 1986 about winding up with exceptions and additions, and Article 185(4), which provides that the partnership can only be wound up by the High Court (Article 7).

2. An insolvent partnership may be wound up under Part VI of the Insolvency Order as an unregistered company involving the insolvency of two or more partners. Articles 184 and 185 are applied with modifications and this involves the application of all the provisions of the Insolvency Order and the Companies (Northern Ireland) Order 1986 about winding up by the High Court with exceptions and additions and with the modifications in Part I of Schedule 2 of this Order (Article 8(1)).
3. This Order also provides for the winding up of corporate partners and the bankruptcy of individual partners of an insolvent partnership in conjunction with the winding up of the partnership as an registered company under Part VI of the Insolvency Order. The provisions of the Insolvency Order about winding up by the High Court apply with the modifications specified in Part II of Schedule 2 to this Order and the provisions about bankruptcy apply with the modifications specified in Part III of that Schedule (Article 8(2)). Petitions cannot be presented under Part IX of the Insolvency Order (bankruptcy) against the partnership or against the individual partners in the name of the firm (paragraph 2 of Part III of Schedule 2). Provisions are also made concerning priority of expenses and debts (Articles 9 and 10).
4. The provisions of Parts II and VIII of the Insolvency Order dealing with voluntary arrangements are applied in relation to corporate and individual members of an insolvent partnership respectively, if the proposal made for a composition or schemes of arrangement includes all the creditors of the partnership (Article 11).
5. This Order also makes provisions in respect of insolvency proceedings against members of an insolvent partnership not involving the winding up of the partnership as an unregistered company (Articles 13 and 14).
6. This Order also makes transitional provisions such that the law in operation immediately before the date on which this Order comes into operation shall continue where a petition was presented before that date, or bankruptcy proceedings were pending on that date. (This includes where a debtor's summons has been served against the partnership or a member of it.) (Article 15).

#### IMPORTATION OF ANIMALS ORDER (NORTHERN IRELAND) 1986

#### GENERAL IMPORT LICENCE

The Department of Agriculture for Northern Ireland, in accordance with the terms of the above legislation, hereby authorises subject to the conditions attaching to this licence, the importation into Northern Ireland of: Cattle for Immediate Slaughter from Great Britain until further notice or unless the licence is revoked by the Department.

#### *Conditions Attaching to this Licence*

1. Cattle must be imported into Northern Ireland via Larne Port between 0900 hours and 1600 hours Monday to Thursday and 0900 and 12 noon Friday or Newry Border Post between 0800 hours and 1400 hours Monday to Thursday and 0800 hours and 12 noon Friday.

**NOTE:** Cattle must not be imported on the appropriate days for the following Public Holidays:

New Year's Day  
St. Patrick's Day  
Easter  
May Bank Holidays  
12th and 13th July  
August Holiday  
Christmas Day  
Boxing Day

2. One working day's advance notice of importation, including the total number of cattle must be given to the Department of Agriculture official at the point of entry and Veterinary Officer or other Department official at the Meat plant of destination.
3. The cattle being imported must be accompanied by a valid health certificate and a schedule giving details of the individual ear numbers, colour, breed, sex and age of the animals to which it relates, the registration number of the vehicle in which the animals are being transported to Northern Ireland, and which is signed by a local Veterinary Inspector appointed by the Ministry of Agriculture, Fisheries and Food.
4. The Health Certificate referred to at 3 above must certify that:
  - 4.1 The herd from which the cattle are being exported to Northern Ireland is officially Tuberculosis and Brucellosis Free in accordance with Directive 64/432; and
  - 4.2 (a) either a declaration has been received from the owner/exporter of the animal stating that it has not been in a herd which has shown evidence of BSE in the last 2 years, or,  
(b) a declaration has not been received; and
  - 4.3 Within 24 hours of export to NI all cattle described on the certificate were clinically examined and were found to be free from evidence of infectious or contagious disease and were fit to travel and their identification marks were seen to be clear and as stated on the schedule.

(NOTE: Where the health history of herds or individual animals is certified, the statements must be correct so far as it is possible to determine, and where applicable, be made on the basis of official records.)
5. The cattle must be transported to Northern Ireland without coming into contact with animals not subject to the same health certification, by transport vehicles which, prior to loading had been cleansed and disinfected with an officially approved disinfectant.
6. Immediately after landing at Larne, imported cattle must be moved direct to the Department's Reception Centre at Redlands Road, Larne, and must remain in the centre until an animal movement licence authorising their movement to premises in Northern Ireland has been issued by or on the authority of the Veterinary Officer in charge of the centre. The animal movement licence must accompany any animal leaving the centre.
7. On clearance by the Veterinary Officer the cattle must be transported direct to the meat plant of destination and be slaughtered within 24 hours of arrival.
8. On arrival at the meat plant the health certificate must be presented to the authorised Department of Agriculture official on duty.

#### GENERAL IMPORT LICENCE

2. One working day's notice of landing including the total number of cattle must be given to the Portal Inspection Centre, Larne (Tel: Larne 273470) or alternatively to the Portal Inspection Office, Belfast (Tel: Belfast 324681).

3. The cattle being imported must be accompanied by a valid health certificate and a schedule giving details of the individual ear numbers, breed, sex and date of birth of the animals to which it relates, the registration of the vehicle in which the animals are being transported to Northern Ireland and signed by a Local Veterinary Inspector appointed by the Ministry of Agriculture, Fisheries and Food.

4. The Health Certificate referred to at 3 above must certify that:

- 4.1 The herd from which the cattle are being exported to Northern Ireland is officially Tuberculosis and Brucellosis free in accordance with Directive 64/432.

- 4.2 Either

- (a) —the herd of origin of the animals is a herd which is EBL free within the meaning of Art. 2(S) of Directive 64/432 as amended by Directive 90/422 and

—within 30 days prior to export all animals more than 12 months old for export to Northern Ireland have given a negative reaction to an individual test for EBL carried out in accordance with Annex G of Directive 64/432 as amended by Directive 90/422, or

- (b) —the animals come from a herd in which there has been no evidence of EBL during the previous 2 years, and,

—bear a special mark which has been approved by an authorised officer of the Ministry of Agriculture, Fisheries and Food, and

—are under 30 months of age and are intended for fattening.

- 4.3 BSE

either a declaration has been received from the owner/exporter stating that the animals have not come from a herd which has shown evidence of BSE in the last 2 years, or,

a declaration has not been received.

- 4.4 JOHNE'S DISEASE

—the cattle for export to Northern Ireland have not been vaccinated against Johne's Disease, and

—the herd from which the cattle are being exported to Northern Ireland and any other herd the animals have been in during the 12 months prior to export is a herd in which there has been no clinical evidence of Johne's Disease for the previous 2 years.

- 4.5 With 24 hours of export to Northern Ireland all cattle described on the certificate were clinically examined, were found to be free from evidence of infectious or contagious disease and were fit to travel, and their identification marks were seen to be clear and as stated on the schedule.

(NOTE: Where the health history of herds or individual animals or statements with regard to residency or movements are certified, the statements must be correct so far as it is possible to determine, and where applicable, on the basis of official records.)

5. All cattle must be transported to Northern Ireland without coming into contact with animals not subject to the same health certification, by transport vehicles which, prior to loading, have been cleansed and disinfected with an officially approved disinfectant.

6. Immediately after landing at Larne imported cattle must be moved direct to the Department's Reception Centre at Redlands Road, Larne, and must remain in the Centre until an animal movement licence authorising their movement to premises in Northern Ireland has been issued by or on the authority of the Veterinary Officer in charge of the Centre. The animal movement licence must accompany any animal leaving the Centre.

7. Cattle imported in accordance with 4.2(b) shall be taken directly from Larne Port to the Northern Ireland farm of destination where they shall be kept in isolation until such time as they go direct for slaughter, in accordance with Directive 64/432 as amended by Directive 90/422.

- b. a declaration has been received from the owner/exporter of the animals stating that the animals have not come from a herd which has shown evidence of BSE in the last 2 years.

#### 4.4 The cattle for export to Northern Ireland have not been vaccinated against Johne's Disease; and

—the herd from which the cattle are being exported to Northern Ireland and any other herd the animals have been in during the 12 months prior to export is a herd in which there has been no clinical evidence of Johne's Disease for the previous 2 years.

#### 4.5 Within 24 hours of export to Northern Ireland all cattle described on the certificate were clinically examined and were found to be free from evidence of infectious or contagious disease and fit to travel and their identification marks were seen to be clear and as stated on the schedule.

(NOTE: Where the health history of herds or individual animals or statements with regard to residency or movements are certified, they must be correct so far as it is possible to determine, and where applicable, on the basis of official records.)

This order, which comes into operation on 1st October, 1991, establishes the monetary limits for the bankruptcy provisions of the Insolvency (Northern Ireland) Order 1989 relating to voluntary arrangements, criminal offences committed by a bankrupt and the issue of warrants for the arrest of a bankrupt.

### THE INSOLVENCY (NORTHERN IRELAND) ORDER 1989

Notice is hereby given that the Department of Economic Development, in exercise of the powers conferred on it by Rule 12.01 of the Insolvency Rules (Northern Ireland) 1991 and Article 359 of, and paragraph 27 of Schedule 5 and paragraph 28 of Schedule 6 to, the Insolvency (Northern Ireland) Order 1989, has made an order entitled "The Insolvency Regulations (Northern Ireland) 1991."

These regulations, which come into operation on 1st October, 1991, deal with certain administrative matters under the Insolvency (Northern Ireland) Order 1989 relating to the accounts of insolvent estates, the disposal of an insolvent's records, the manner of distribution of insolvent estates, the manner in which moneys received by an insolvency practitioner are to be handled, the remuneration of the official receiver and deeds of arrangement.

Notice is hereby given that the Department of Economic Development has made a commencement order entitled the Companies (1990 No. 2 Order) (Commencement No. 4) Order (Northern Ireland) 1991 (S.R. 1991 No. 398 (c.18)). The Order brings into operation on 1st October, 1991, certain provisions of the Companies (No. 2) (Northern Ireland) Order 1990 ("the 1990 (No. 2) Order").

Article 2 brings into operation Article 74 of and paragraphs 2 to 7 and 13 of Schedule 5 to the 1990 (No. 2) Order (together with Article 78 in so far as it relates to those paragraphs). Article 74 of the 1990 (No. 2) Order substitutes new provisions on a company's annual return for the existing provisions contained in the Companies (Northern Ireland) Order 1986 ("the 1986 Order") and is brought

into operation subject to the transitional and saving provisions set out in Articles 3 and 4. Paragraphs 2 to 7 of Schedule 5 to the 1990 (No. 2) Order make a number of minor amendments to certain provisions of the 1986 Order requiring particulars of directors to be delivered to the registrar of companies or entered into registers kept by the company. Paragraphs 2 and 6 are brought into operation subject to the transitional and saving provisions made by Article 5. Paragraph 13 of Schedule 5 to the 1990 (No. 2) Order substitutes a new provision with respect to the registered numbers of companies for an existing provision of the 1986 Order. Article 2 also brings into operation certain repeals effected by Schedule 6 to, and Article 113 of, the 1990 (No. 2) Order.

Articles 3 and 4 enable a company not due to file an annual return for 1991 before the coming into operation of Article 74 to file, notwithstanding the coming into operation of that Article, as annual return under the existing provisions of the 1986 Order relating to annual returns rather than under the new provisions. (A company which was due to file an annual return for 1991 before 1st October, 1991, but which has not done so remains obliged to file a return under the existing provisions of the 1986 Order relating to annual returns by virtue of Article 74(2) of the 1990 (No. 2) Order). Articles 3 and 4 make certain other transitional provisions necessary for the operation of this arrangement, together with a saving provision maintaining an exemption from the requirement to file an annual return for 1991 applicable to certain companies under those existing provisions.

Article 5(1) concerns companies which, as a consequence of the coming into operation of paragraph 2 of Schedule 5 to the 1990 (No. 2) Order, come under an obligation to amend their register of directors kept under Article 296 of the 1986 Order (mainly private companies not being subsidiaries of a public company which must register the dates of birth of their directors). It gives them a period of grace within which to comply and also relieves them of the obligation in Article 296(2) to notify the changes made to the registrar of companies. Article 5(2) requires certain companies incorporated outside Northern Ireland which carry on business in Northern Ireland to make a return to the registrar of companies of the dates of birth of their directors by 1st January, 1992.

Form 371a is a blank form. Forms 371b and 371s are forms which will be provided to companies by the registrar of companies already partly completed from the registrar's records. Companies will be able to return them amended and completed as necessary.

Companies will also be able to use forms 371b and 371a to notify a change of registered office. In addition companies will be able to use form 371s to notify the resignation etc., of a director or secretary and changes in the particulars of existing directors and secretaries but not the appointment of new directors or secretaries. For this purpose a form 296, as prescribed by these Regulations will have to be used. Form 371s may also be used to notify the place where any register of debenture holders or duplicate of such a register is kept, and any change in that place and the place where the register of members is kept and any change in that place. The Regulations also permit particulars of directors to be given in an annual return in form 371s if a form 296 is annexed to it.

The Regulations prescribe the classification scheme for giving a company's type in its annual return as required by Article 372(1)(b) of the 1986 Order (as substituted by the 1990 (No. 2) Order). They also prescribe for the purposes of that Article, which requires a

company to give its principal business activities in its annual return, the system of classifying business activities. The system prescribed for this purpose is the VAT Trade Classification plus three extra codes. Copies of the VAT Trade Classification are available free of charge from local VAT Enquiry Offices.

The present annual return form is revoked as from 1st October, 1991, except that it may continue to be used after that date in respect of years up to and including 1991 under the transitional and saving provisions contained in Article 74(2) of the 1990 (No. 2) Order and Articles 3 and 4 of the Companies (1990 No. 2 Order) (Commencement No. 4) Order (Northern Ireland) 1991 (S.R. 1991 No. 398 (c.18)).
