DEPARTMENT OF AGRICULTURE

PLANT HEALTH (WOOD AND BARK) (AMENDMENT) ORDER (NORTHERN IRELAND) 1991

This Order further amends the Plant Health (Wood and Bark) Order (Northern Ireland) 1989 ("the Principal Order") which implements Council Directive 77/93/EEC (O.J. No. L26, 31.1.77, p. 20), as amended by the instruments listed in Schedule 6 of the Principal Order (which Article 11 of this Order updates) by:

- (a) implementing that part of Council Directive 89/439/EEC (O.J. No. L212, 22.7.89, p.106) relating to wood and isolated bark which, in certain cases, allows the issue of a phytosanitary certificate in a country other than that of origin in certain circumstances;
- (b) implementing Commission Directive 90/490/EEC (O.J. No. L271, 3.10.90, p.28) by altering the conditions of landing with regard to wood, wood chips, particles of wood, wood waste or scrap of conifers grown in Canada, China, Japan, Korea or the

United States of America and prohibits the landing of fuel wood of conifers from those countries; and

- (c) making minor amendments to the Principal Order. These include the renaming of "mill certificates of debarking" as "mill certificates".

TEMPORARY SPEED LIMIT MOTORWAY M1

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by Article 51(1) of The Road Traffic (Northern Ireland) Order 1981 and of all other enabling powers made on 13th September, 1991, an Order entitled Temporary Speed Limit (Motorway M1) (No. 6) Order (Northern Ireland) 1991 (S.R. 1991 No. 424) which will come into operation on 13th October, 1991.

The purpose of the order is to prohibit the driving of motor vehicles on lengths of both carriageways of the Motorway M1 in the vicinity of Junction 11 (Ballinacorr) at more than 50 miles per hour for a period of 34 days commencing on 13th October, 1991, in the interests of safety while roadworks are in progress.

TEMPORARY SPEED LIMIT ROUTE A1 (T4)

The purpose of the order is to prohibit the driving of motor vehicles at more than 40 miles per hour on part of Route A1 (T4) between Banbridge and Dromore for a period of 86 days commencing on 7th October, 1991, in the interests of safety while roadworks are in progress.

These Regulations which come into operation on 14th October, 1991, amend the Motor Vehicles (Driving Licences) (Heavy Goods and Public Service Vehicles) Regulations (Northern Ireland) 1991, by reducing from 7 days to 5 days, the period within which a person unable to produce his driving licence for a heavy goods vehicle or public service vehicle when required by a policeman to do so, must produce that licence for examination at a police station.
