N.E. Diversion Drainage Scheme

The Department of Agriculture for Northern Ireland hereby gives Notice in Pursuance of Article 12 of the Drainage (Northern Ireland) Order 1973 that a scheme has been prepared for the improvement of drainage in the Carrickfergus area.

The proposed route of the scheme is from an inlet on the Sullatober Water Branch near Bashfordsland running in an easterly direction, crossing Downshire Stream, Bluefield Stream, Cloughlands Stream, and Trailcock Stream to the Copeland Water west of the Beltoy Road. The scheme involves approximately 17.00 m of concrete pipeline ranging from 1200 mm to 1800 mm diam, complete with 16 number insitu concrete manholes, outlet structure and cascade and 3 number inlet structures.

 All landings of semen to which this licence applies shall be in accordance with the provisions of the Artificial Reproduction of Animals (Northern Ireland) Order 1975 and with the following provisions.

- 2. Each consignment of semen shall be accompanied by an animal health certificate in accordance with Council Directive 90/429/EEC (published in Official Journal No. L224/62 of 18th August 1990), signed by an official veterinarian of the exporting country. The certificate must state that the semen was collected from boars on a collection centre which contains only animals that have not been vaccinated against Aujeszky's Disease and that have reacted negatively to the serum neutralisation or ELISA tests for Aujeszky's Disease in accordance with the above Directive.
- 3. The consignment of semen shall be transported in a flask sealed in the presence of the certifying Veterinary Officer.
- 4. The flask shall be clearly marked with the name and address of the despatching Artificial Insemination Centre and the number(s) of the animal health certificate referred to at 2 above.
- 5. Consignees must notify, in writing, the Department's Divisional Veterinary Officer (Imports), Dundonald House, Belfast, of their intention to import semen, in particular the nature of the consignment and the anticipated arrival date, at least 24 hours in advance of the expected date of import.
- 6. The animal health certificate must be presented on entry to:
 - (a) an Imports Inspector of the Department, in the case of a consignment from GB; or
