##### POULTRY AND HATCHING EGGS FOR BREEDING PURPOSES FROM THE REPUBLIC OF IRELAND

The Department of Agriculture for Northern Ireland, in accordance with the terms of the above legislation, hereby authorises subject to the conditions attaching to this licence the importation into Northern Ireland from the Republic of Ireland of hatching eggs and poultry for breeding purposes until further notice or unless the licence is revoked by the Department.

##### CONDITIONS ATTACHED TO GENERAL LICENCE DANI/GEN/92/49

1. All importations of poultry and hatching eggs for breeding purposes shall be in accordance with the provisions of the *Diseases of Animals (Importation of Poultry) Order (Northern Ireland) 1965* and with the provisions of this licence.
2. Each consignment must be accompanied by a health certificate or copy thereof in the form laid down in Annex IV of Directive 90/539, amended and signed by an official veterinary surgeon.
3. The health certificate must be endorsed to the effect that:
  - (a) the hatching eggs/day-old chicks/poultry\* described on the certificate comply with the relevant Commission decision establishing Ireland as a Newcastle Disease free member state;
  - (b) the flocks of origin of hatching eggs/day-old chicks/poultry\* must have been monitored for *Salmonella Enteritidis* and *Typhimurium* in accordance with the Republic of Ireland Code of Practice.
  - (c) the flocks of origin of hatching eggs/day-old chicks/poultry\* are reared on premises approved under Article 6 of EC Directive 90/539.

\* delete as appropriate.

4. The health certificate must be contained on a single sheet of paper and written in English.

*Definitions:*

1. (a) Poultry includes domestic fowl, turkeys, ducks, geese, partridges, pheasants, quail, pigeons and guinea fowl reared or kept in captivity for breeding.
  - (b) Hatching eggs means eggs for incubation, laid by poultry defined in (a).
  - (c) Day old chicks means all poultry less than 72 hours old, not yet fed; except for Barbary ducks which may be fed.
  - (d) Poultry for breeding purposes means poultry 72 hours old or more, intended for the production of hatching eggs.
  - (e) Member state means a member state of the European Community.

## TEMPORARY SPEED LIMIT, ROUTE A3, PORTADOWN
