MISUSE OF DRUGS ACT 1971
Sections 13(2) and 15

Temporary direction withdrawing certain powers in relation to controlled drugs

Dr Manohar Vasudev Ray

The Secretary of State, in pursuance of Subsection (2) of Section 13, and by virtue of Section 15, of the Misuse of Drugs Act 1971, by this Direction prohibits Dr Manohar Vasudev Ray MB, BS, a doctor within the meaning of that Act, whose registered address is Stoodley, 84 Walton Road, Stockton Heath, Warrington WA4 6NP, from prescribing, administering and supplying and from authorising the administration and supply of any drug which was, on 16 October 1991 a controlled drug within the meaning of that Act.

This direction does not extend to the doing of anything in circumstances where it may lawfully be done without being a doctor.

NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Article 359 of the Insolvency (Northern Ireland) Order 1989 and section 59 of the Insurance Companies Act 1982, with the concurrence of the Department of Economic Development, and after consulting the Committee existing for that purpose under Article 360 of the Insolvency (Northern Ireland) Order 1989, has made a Statutory Rule entitled the Insurance Companies (Winding-Up) Rules (Northern Ireland) 1992.

These Rules, which come into operation on 1 September 1992 apply to proceedings for the winding up of insurance companies commenced on or after that date. They provide for the carrying on by the Liquidator of the long-term business of the company, unless

and until the Court otherwise orders, and for the separate winding up of the long-term and any other business of the company.

More particularly the Rules provide for —

any necessary identification of the assets and liabilities of the company's long-term business and those of its other business; methods of valuation of long-term business policies for the purpose of determining the amount of any excess of assets over liabilities in the company's long-term business; methods of valuation of long-term business policies for the purposes of proof in the winding up of the long-term business where the Court orders the Liquidator to stop carrying on the long-term business; and methods of valuation of general business policies which apply both for the purpose of determining the amount of any excess of assets over liabilities in the general business of a composite insurance company and for the purposes of proof in the winding up of a general business company or of the general business of a composite insurance company; and methods of calculating the Liquidator's remuneration on a time and rate basis as reflected in the provisions of the Insolvency Rules (Northern Ireland) 1991.

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred by Sections 21(9), 21(10), 22, 46(3), 56(1), 56(6), 56(8), 57(1), 68, 165(2) and 167(1) of, and Schedule 3 to the Social Security Administration (Northern Ireland) Act 1992 and Article 6 of the Forfeiture (Northern Ireland) Order 1982 has made a Statutory Rule entitled the Social Security Commissioners Procedure (Amendment) Regulations (Northern Ireland) 1992.

These regulations, which come into operation on 1 September 1992, amend the Social Security Commissioners Procedure Regulations (Northern Ireland) 1987 by extending the definition of appeal tribunal to include a disability appeal tribunal constituted in accordance with Section 41 of the Social Security Administration (Northern Ireland) Act 1992. The definition has also been amended to refer to the provision in the 1992 Act which social security appeal tribunals are constituted in accordance with.
