

## HURTTLETOOT ROAD, ANTRIM

The Department hereby gives notice of its intention on the completion of such works as it considers necessary for the provision of alternative facilities for road traffic to make an order under Article 40 of the Roads (Northern Ireland) Order 1980 the effect of which would be to abandon a length of approximately 103 metres of Hurtletoot Road, Antrim in the townland of Rathbeg and County of Antrim.

The length of road proposed to be abandoned is delineated on a map which, together with a copy of the draft order, may be inspected free of charge at all reasonable hours during the period from 7th August 1992 to 14th September 1992 at the Department's Roads Service Headquarters, Room 214, Commonwealth House, 35 Castle Street, Belfast BT1 1GU; at the Department's Divisional Roads Service, Ballymena Division, County Hall, Galgorm Road, Ballymena; and at the Department's Divisional Roads Service Section Office, "Ferrard", Railway Street, Antrim.

## BEECH DRIVE, BALLYMENA (FOOTWAY)
