SUPREME COURT RULES COMMITTEE

THE RULES OF THE SUPREME COURT (NORTHERN IRELAND) (AMENDMENT No. 3) 1992

(SR 1992 No. 399)

These Rules contain miscellaneous amendments, mostly of a minor character, of the Rules of the Supreme Court (Northern Ireland) 1980. One amendment to Order 59 empowers the Court of Appeal to revise the amount of damages awarded by a jury where the Court considers them excessive or inadequate, instead of ordering a new trial.
