*Rasharkin Road Drain, Ballymoney*

The works involve laying reinforced concrete pipes ranging in size from 600 mm to 900 mm diameter of length approximately 150 m, with associated manholes and outlet structure.

The works will be carried out using environmentally sensitive techniques. Having determined that the proposed works are not by reason, amongst other things, of their nature, size or location likely to have significant environmental effects, the Department does not intend to prepare an Environmental Statement.
