NORTHERN IRELAND COURT SERVICE

Notice is hereby given that the Lord Chancellor, in exercise of the powers conferred on him by Article 47 of the County Courts (Northern Ireland) Order 1980 has allowed a Statutory Rule entitled the County Court (Amendment No. 4) Rules (Northern Ireland) 1992 to be made.

These rules, which come into operation on 1st January, 1993, amend the County Court Rules (Northern Ireland) 1981 to :

- (i) take account of amendments made to the Civil Jurisdiction and Judgments Act 1982 by the Civil Jurisdiction and Judgments Act 1991; and
- (ii) introduce a notice of settlement procedure.

NORTHERN IRELAND OFFICE

Notice is hereby given that in exercise of the powers conferred by Article 27 of the Criminal Justice (Confiscation) (Northern Ireland) Order 1990, the Secretary of State has made an Order entitled the Criminal Justice (Confiscation) (Designated Countries and Territories) (Amendment) (Northern Ireland) Order 1992 [Statutory Rule 1992 No. 469].

This Order, which comes into operation on 11th January 1993, amends the Criminal Justice (Confiscation) (Designated Countries and Territories) (Northern Ireland) Order 1991 ("the principal Order") which provides that, subject to certain modifications, the Criminal Justice (Confiscation) (Northern Ireland) Order 1990 applies to an order made by a court in any of the countries or territories listed in Schedule 1 to the principal Order (being countries and territories designated under section 26 of the Drug Trafficking Offences Act 1986) for the purpose of recovering payments or other rewards received in connection with drug trafficking or their value, and to proceedings which have been or are to be instituted in a designated country or territory and may result in such an order being made there.

Article 2 of this Order amends the list of designated countries in the principal Order by the addition of Afghanistan, Argentina, Brazil, Burma, Cameroon, Czechoslovakia, Germany, Greece, Guyana, Honduras, Hungary, Ivory Coast, Monaco, Nepal, Pakistan,

Peru, Portugal, Seychelles, Sri Lanka, Syria, Uruguay and Venezuela. Article 3 makes consequential amendments to the principal order.

FAIR TRADING ACT 1973

Reference to the Monopolies and Mergers Commission

THE SUPPLY OF FINE FRAGRANCES

The Director General of Fair Trading in exercise of his powers under sections 47(1), 49(1) and 50(1) of the Fair Trading Act 1973 hereby refers to the Monopolies and Mergers Commission the matter of the existence or the possible existence of a monopoly situation in relation to the supply in the United Kingdom for retail sale of fine fragrances.

The Commission shall investigate and report on the questions whether a monopoly situation exists and if so

- (a) by virtue of which provisions of sections 6 to 8 of the said Act that monopoly situation is taken to exist;
- (b) in favour of what person or persons that monopoly situation exists;
- (c) whether any steps (by way of uncompetitive practices or otherwise) are being taken by that person or persons for the purpose of exploiting or maintaining the monopoly situation and if so by what uncompetitive practices or in what other way;
- (d) whether any action or omission on the part of that person or persons is attributable to the existence of that monopoly situation and if so what action or omission and in what way it is so attributable; and
- (e) whether any facts found by the Commission in pursuance of their investigations under the preceding provisions of this paragraph operate or may be expected to operate against the public interest.

For the purpose of this reference :

'fine fragrances' means perfumes (otherwise known as concentrates), eaux de parfum, eaux de toilette, eaux de cologne and after-shave lotions which are supplied to retailers at a resale price exceeding £15 per 50 millilitres;

'resale price' has the meaning given to it by section 11(2) of the Resale Prices Act 1976; and

where a container of perfume, eau de parfum, eau de toilette, eau de cologne or after-shave lotion which if supplied alone would be supplied to retailers at a resale price exceeding £15 per 50 millilitres is supplied in combination with any other goods at an inclusive resale price for the container and those goods, the inclusive resale price of the container and those goods is to be treated as the resale price of the container.

The Commission shall report upon this reference within a period of nine months from the date hereof.

THE PETROLEUM (PRODUCTION) (SEAWARD AREAS) REGULATIONS 1988

1. Further to the Notice published on 31st July, 1992, the Secretary of State for Trade and Industry invites applications, in accordance with the Petroleum (Production) (Seaward Areas) Regulations 1988 (SI 1988 No. 1213), as amended by the Petroleum (Production) (Seaward Areas) (Amendment) Regulations 1990 and the Petroleum (Production) (seaward Areas) (Amendment) Regulations 1992 (in this Notice called "the Regulations"), for petroleum production licences in respect of the blocks specified in Schedules 1 and 2 to this notice and delineated on maps deposited in the Library at the Department of Trade and Industry, 1 Palace Street, London SW1E 5HE. The maps may be inspected by prior appointment (Telephone No. 071-238 3042) between 09.15 and 16.45 hours Monday to Friday until Tuesday 9th March, 1993.

Consideration for and Conditions of Licences

2. Licences issued in respect of blocks shown on the map at Schedule 1 and listed in Schedule 2 will have an initial term of nine years with a second term of fifteen years. This second term may be extended beyond fifteen years for a further period of twenty-four years. These licences will be subject to the model clauses set out in Schedule 4 to the Petroleum (Production) (Seaward Areas) Regulations 1988, apart from those conditions relating to the duration of the licences and the surrender of the parts of the licenced area.
3. The consideration required in respect of production licences granted as a result of this invitation will be :
 - (a) an initial payment, at the time the offer of a licence is accepted, of £60 for each square kilometre comprised in the licenced area;
 - (b) subsequent annual payments determined according to the following provisions :
 - (i) on the third, fourth and fifth anniversaries of the date of commencement of the licence term the sum of £20 will be payable for each square kilometre comprised in the licenced area; on the sixth, seventh and eighth anniversaries the sum of £40 will be payable for each square kilometre comprised in the licenced area; on the ninth, tenth and eleventh anniversaries (following exercise of the option to continue as to the remaining period of the licence) the sum of £200 for each square kilometre to which the licence then relates; on the twelfth anniversary £650 per square kilometre and so on, rising by annual increments of £450 until an annual sum of £5,600 is payable for each square kilometre comprised in the licenced area;
 - (ii) the payments specified in sub-paragraph 3(b)(i) above will be subject to variation as follows :
 - (aa) The annual payments will be increased or subsequently reduced at two-yearly intervals in line with movements in the Index of the Price of Crude Oil acquired by Refineries (published in the Digest of UK Energy Statistics) if the Minister so determines. The Minister will give notice of any such determination ("biennial determination") during the month preceding the thirteenth anniversary of the date of commencement of licences or any subsequent two-yearly anniversary, and will specify in the notice the increase or reduction in the amount payable. Movements in the Index will be calculated by reference to a comparison between the arithmetic mean of the Index levels for the two latest calendar years for which figures are available at the time when the determination is made, and the arithmetic mean of the Index levels for 1990 and 1991. In the event that the Index of the Price of Crude Oil acquired by Refineries ceases to be published, the Minister may substitute arrangements for redetermination of annual payments having substantially similar effect to those set out above based on such other comparable Index as he may determine.
4. Licences may be granted subject to special conditions governing the notice required for, and the timing and circumstances of, operations carried out thereunder. The Department of Trade and Industry will make copies of these conditions available as soon as possible.
5. (a) Applicants will be required to submit to the Department of Trade and Industry a work programme of seismic and other forms of exploration not involving drilling. Proposals for drilling will be acceptable but not required. The work programme will be carried out in the first three years ('the first part') of the initial term of the licence. However, the Secretary of State will be prepared to consider using his discretion to extend the first part of the initial term to a maximum of four years in individual cases. (In such cases the total length of the initial term will remain at nine years).
- (b) If licensees do not wish to continue into the second part of the initial term they may surrender the licence at the end of the first part of the initial term.
- (c) There will be no requirement for licensees to submit a work programme to the Department of Trade and Industry for the second part of the initial term. However, a decision by the licensees to continue into the second part of that term will be taken to mean that, if no well has already been drilled under the licence, they would plan to drill at least one exploration well before the expiry of the initial term. The number of wells drilled by the end of the initial term will determine how much acreage may be retained for the second term, in accordance with the provisions of paragraph 6 below, unless circumstances in individual cases justify an alternative approach.

(bb) The increase or reduction specified in a biennial determination will be payable or take effect on the anniversary of the date of commencement of the licence next following the date of the relevant determination.

(cc) No biennial determination will have effect so as to reduce the annual payments below the levels set in sub-paragraph 3(b)(i).

(dd) The Minister will not make a biennial determination increasing or reducing the amounts payable, where that increase or reduction would be 5% or less of the levels set following the previous biennial determination.

(c) A royalty (provided for in Clauses 10-13 of Schedule 4 to the Regulations) at the rate of 12.5% payable in respect of petroleum won and saved from any field which is neither :

- (i) a relevant new field for the purposes of the Petroleum Royalties (Relief) Act 1983;
- nor
- (ii) a relevant Southern Basin field for the purposes of the Petroleum Royalties (Relief) and Continental Shelf Act 1989.

6. Licensees will be allowed to retain acreage at the end of the initial term according to the following provisions unless the Secretary of State decides otherwise. One exploration well drilled in the initial term will allow retention of up to a quarter of the area held by the licensee at the end of the initial term. Two exploration wells drilled will allow retention of up to half the area held by the licensee at the end of the initial term. Three or more exploration wells drilled will allow retention of the whole of the area held by the licensee at the end of the initial term. Wells drilled in both parts of the the initial term of the licence will be allowed to count for this purpose. Licensees will be able to opt to retain less than the maximum allowed. In order to qualify under these provisions, wells must be drilled to geological targets where hydrocarbons are expected to be present or for the purposes of establishing the source and reservoir potential of the overall geological section of the licensed area.
7. The Secretary of State will be prepared to give consent to the proposals, where these are otherwise acceptable, to assign interests in licences to others at the end of the first part of the initial term.

Applications for Licences

8. In respect of all blocks listed in Schedule 2 :
 - (a) applications should be made on a standard application form available from the Department of Trade and Industry. Applicants should note that the Secretary of State will entertain applications for blocks either singly or in tranches of up to six blocks;
 - (b) applications should be delivered between 09.30 and 12.00 hours on Tuesday, 9th March, 1993, to the Oil & Gas Division of the Department of Trade and Industry at 1 Palace Street, London SW1E 5HE, together with a remittance in respect of the appropriate application fee of £3,700;
 - (c) no applications will be accepted after 12.00 hours on Tuesday, 9th March, 1993;
 - (d) applicants are requested to indicate where possible any preference they attach to the blocks or tranches applied for and should indicate if blocks or tranches applied for are alternatives;
 - (e) applicants are requested to provide details of the work programme they propose to carry out if awarded a licence;
 - (f) applicants should note that they are requested to submit a statement of their policy with regard to health and safety, and for the first time, to submit a statement of their policy with regard to the environment;
 - (g) further guidance on the material with which applicants may support their applications is given in Guidance Notes available from the Department of Trade and Industry;
 - (h) copies of documents referred to in the text of this notice as being available from the Department of Trade and Industry may be obtained from the Licensing Branch (Room 3.2M. 23), Oil & Gas Division, Department of Trade and Industry, 1 Palace Street, London SW1E 5HE (Telephone No. 071-238-3211/3212).
9. Applicants will be judged against the background of the continuing need for expeditious, thorough, efficient and safe exploration to identify oil and gas resources of the UK Continental Shelf, with due regard to environmental considerations. The financial and technical capacity of each applicant will be established as far as possible before competing applications are evaluated. Applicants must also meet a threshold of acceptability for other criteria, including technical competence, health and safety and environmental policies. Once these threshold criteria have been met, applications will be evaluated on the basis of the following technical criteria :
 - the quality of geological analysis related to the block or tranche being applied for and the identification of prospects (including whether work done was innovative);
 - the quality of the work programme submitted for evaluating the full potential of the block or tranche;
 - the experience or technical databases (e.g. of relevant seismic data) of applicants in each applicant group.

The first two of these criteria are particularly important. Where applicants hold or have held licences, their overall record on exploration and exploitation may also be taken into account, but no preference will be given to such licensees as a result of holding or having held a licence.

10. Following examination of all applications the Secretary of State will select the applicants to whom he is prepared to award licences. If there are two or more applicants for a block or tranche of blocks who would be equally acceptable to the Secretary of State as licensees for that block or tranche of blocks he may suggest that the licence should be held jointly by some or all of such applicants.
11. The selected applicants will be offered licences on condition that within 14 working days of the date on which the Secretary of State makes the offer of an award :
 - (a) they confirm acceptance of a work programme proposed by the Secretary of State following discussion with the applicants concerned;
 - (b) they remit to the Secretary of State the appropriate payment referred to in paragraph 3(a) above; and
 - (c) they confirm in writing that they accept any special conditions or restrictions of the sort referred to in paragraph 4 above.
12. Unsuccessful applicants will be notified in writing.

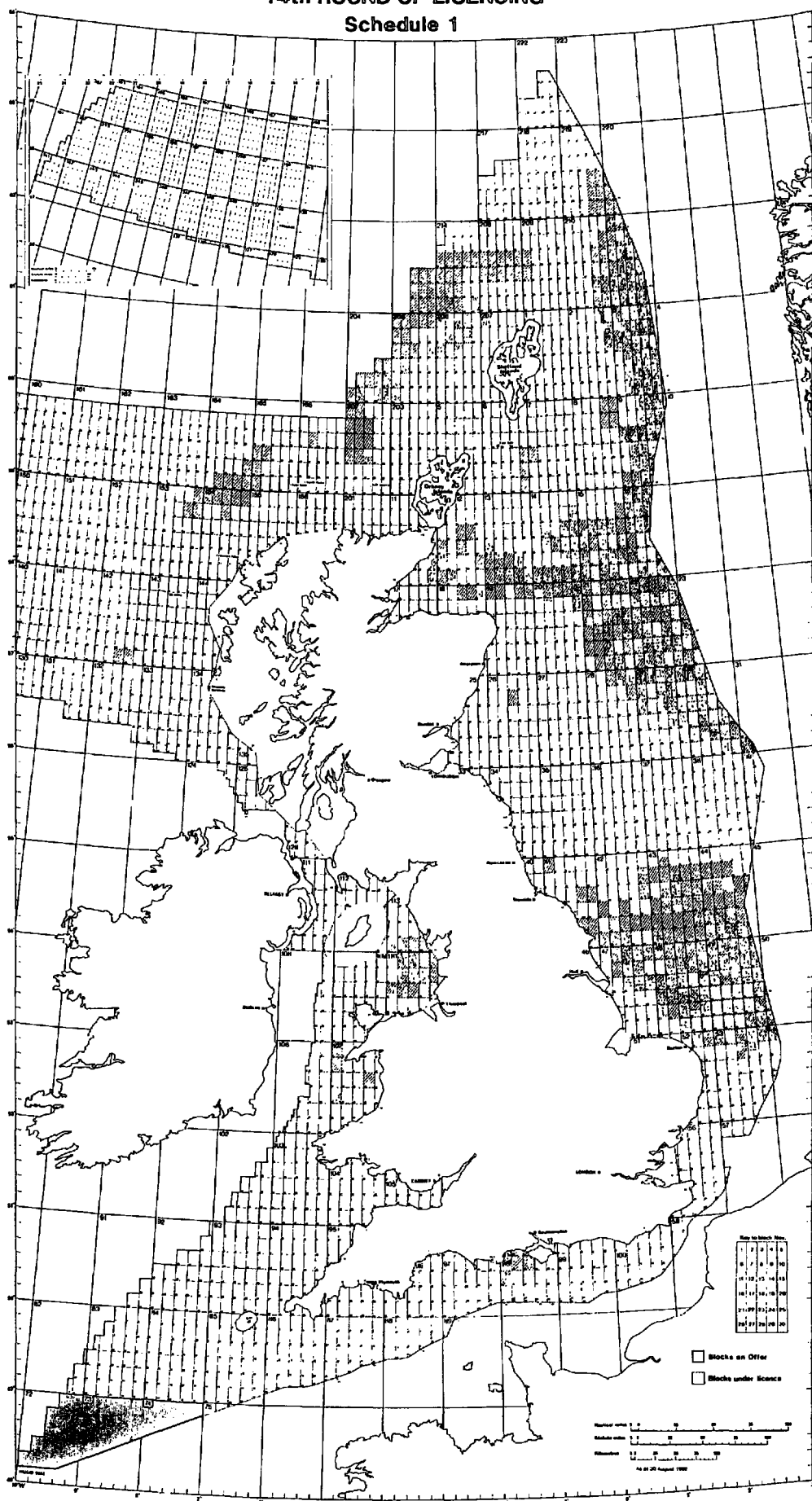

THE POST OFFICE INLAND PARCEL POST AMENDMENT
(No. 3) SCHEME 1992

Made 23rd November 1992
Coming into operation 30th November 1992

The Post Office, by virtue of the powers conferred upon it by section 28 of the Post Office Act 1969, and of all other powers enabling it in this behalf, hereby makes the following Scheme :

Commencement and citation

1. — (1) This Scheme shall come into operation on 30th November 1992 and may be cited as the Post Office Inland Parcel Post Amendment (No. 3) Scheme 1992.
- (2) This Scheme shall be read as one with the Post Office Inland Parcel Post Scheme 1989 (Post Office Scheme P1/1989) (hereinafter called "the Scheme") as amended by the Post Office Inland Parcel Post Amendment (No. 1) Scheme 1990 (Post Office Scheme P1/1990) and the Post Office Inland Parcel Post Amendment (No. 2) Scheme 1991 (Post Office Scheme P1/1991)

Cash on Delivery

2. — (1) In sub-paragraph (1) of paragraph 27 of the Scheme, the amount "£1.60" shall be deleted and "£2.00" inserted in its place.
- (2) In sub-paragraph (2) of paragraph 27 of the Scheme, the amount "£350" shall be deleted and "£500" inserted in its place.
- (3) In sub-paragraphs (3) and (4) of paragraph 27 of the Scheme, the expression "the Despatch/Inpayment Document" shall be deleted and "the Cash on Delivery (Inland) Inpayment Document" inserted in its place.
- (4) In sub-paragraph (5) of paragraph 27 of the Scheme, the amount "£1.20" shall be deleted and "£1.70" inserted in its place.
- (5) In sub-paragraph (2) of paragraph 28 of the Scheme, the amount "£50" shall be deleted and "£100 (£250 for deliveries to business addresses)" inserted in its place.

Rates of Postage

ULSTER SAVINGS CERTIFICATES

Common Extension Terms

The Department of Finance and Personnel has issued a Direction decreasing from 5.01% to 3.75% per annum the rate of interest on Ulster Savings Certificates to which common extension terms apply.

The new rate will operate and accrue from 1st December, 1992 and until further notice.

The common extension terms apply to Certificates of the National Defence, Supplementary, Sixth, Seventh, Eighth, Ninth, Tenth, Eleventh, Twelfth, Fourteenth, Sixteenth, Eighteenth, Nineteenth, Twenty-first, Twenty-third, Twenty-fourth, Twenty-fifth, Twenty-sixth, Twenty-seventh, Twenty-eighth, Twenty-ninth, Thirtieth, Thirty-first, Thirty-second and Thirty-third Issues.

The common extension terms were introduced by regulations made on 15th June, 1982 (S.R. 1982 No. 178).

Fortieth and Sixth Index Linked Reinvestment Issues

The Department of Finance and Personnel has also made Directions stating the terms of a new Fortieth Reinvestment Issue and a new Sixth Index Linked Reinvestment Issue of Ulster Savings Certificates available only to holders who are reinvesting from the proceeds of their existing matured Certificates.

The Thirty-ninth Reinvestment and Fifth Index Linked Reinvestment Issues of Ulster Savings Certificates were withdrawn from sale on 12th November, 1992.

Certificates of the new Fortieth Reinvestment and Sixth Index Linked Reinvestment Issues will be issued on or after 13th November 1992, subject to a basic unit of £25 and a maximum holding of £10,000 (400 units) in each Issue irrespective of any holding of any other Issue.

Fortieth Reinvestment Issue

Certificates of the new Fortieth Reinvestment Issue will earn interest at three monthly intervals from date of purchase and will grow in value until fifth anniversary of purchase in accordance with the following table :

THE SHEEP ANNUAL PREMIUM REGULATIONS (NORTHERN IRELAND) 1992

Notice is hereby given that the Department of Agriculture for Northern Ireland in exercise of the powers conferred on it by Section 2(2) of the European Communities Act 1972 and of all other powers enabling it in that behalf has made Regulations entitled The Sheep Annual Premium Regulations (Northern Ireland) 1992 (S.R. 1992 No. 476). The Regulations came into operation on 15th November, 1992.

The Regulations revoke and remake with amendments the Sheep Annual Premium Regulations (Northern Ireland) 1987 (S.R. 1987 No. 87) ("the 1987 Regulations") as amended. The 1987 Regulations made provision for the implementation of Commission Regulation (EEC) No. 3007/84 which laid down detailed rules for the payment of premium to producers of sheepmeat. The general rules on the common organisation of the market in sheepmeat and goatmeat are laid down by Council Regulation (EEC) No. 3013/89 (O.J. No. L289. 7.10.89.p.1) and Article 5 of that Regulation provides for the payment of a premium to producers of sheepmeat.

The principal changes of substance made by the Regulations are that they :

- amend the definition of an "authorised officer" so as to include any person, whether or not an officer of that authority, authorised by the competent authority (regulation 2(2));
- require producers to keep, retain and produce a register containing specified information (regulation 4);
- extend the powers of an authorised officer to inspect records including those kept by means of a computer and confer power to seize and retain such records (regulation 5(5));

(d) require a producer or an employee, servant or agent of a producer to give an authorised officer such assistance as he may reasonably request (regulation 6); and

(e) provide for interest on a payment returnable to the Department under Article 6 of the Commission Regulation (regulation 8) and specify the rate of interest (regulation 7).

Improvements to Portadown Flood Defences

The Department of Agriculture for Northern Ireland hereby gives Notice in pursuance of Article 12 (as amended) of the Drainage (Northern Ireland) Order 1973 that it proposes to carry out a Drainage Scheme at Portadown.

The proposed scheme involves the construction of floodwalls and embankments along the banks of the Rivers Bann, Ballybay (also known as Corcrain) and in the catchment of the River Annagh at Portadown.

On the River Bann defences are proposed along both banks from the boat house area to the northern boundary of Ulster Carpet Mills.

On the Ballybay River defences are proposed on both banks from its confluence with the River Bann into the Peoples Park.

In the Annagh catchment embankments are proposed at Ripley Mews, Orchard Drive and Orchard Park.

Having determined that the proposed works are by reason amongst other things of their nature, size or location, likely to have significant environmental effects it is the Department's intention to prepare an Environmental Statement.

A scheme display may be inspected free of charge by any person during the period 7th December, 1992 to 4th January, 1993 (inclusive) at Portadown Town Hall between the hours of 10.00 am to 4.00 pm Monday to Friday. (Exclusive of public holidays).
