#### SUPREME COURT RULES COMMITTEE

RULES OF THE SUPREME COURT (NORTHERN IRELAND) (AMENDMENT) 1993

(SR 1993 No. 143)

These Rules amend the Rules of the Supreme Court (Northern Ireland) 1980 so as:

- (a) to assign certain business to the Bankruptcy and Companies Office:
- (b) to amend the originating summons procedure;
- (c) to reduce the rate of interest on judgment debts from 15% to
- (d) to grant wider discretion to the Court to permit further affidavits to be used in judicial review proceedings;
- (e) to provide for appeals by way of case stated to the Court of Appeal in certain matters arising under the Building Regulations (NI) Order 1979 and from decisions on a point of law from a Child Support Commissioner; and
- (f) to provide for the reciprocal recognition and enforcement of judgments under the Lugano Convention and the Civil Jurisdiction and Judgments Act 1991.

#### DEPARTMENT OF AGRICULTURE

ANGLING WATERS (DEVELOPMENT SCHEMES) REGULATIONS (NORTHERN IRELAND) 1992

The Department of Agriculture for Northern Ireland has received an application under the provisions of the above Regulations from Sion Mills Angling Club for the development of game angling on a stretch of the River Mourne, Co. Tyrone. The Scheme extends on the East bank from Sion Mills footbridge downstream to Strabane and affects certain stretches in the townlands of Drumnaboy and Stragullin. On the West bank the Scheme extends upstream from Victoria Bridge and affects certain stretches in the townlands of Liscreevaghan, Clady Sproul and Mulvin more particularly defined in the Scheme.

Whereas the owner of the fishing rights in these waters is unknown or cannot be found the Department proposes to authorise the development of the derelict waters as defined in accordance with the Scheme submitted by the applicant.

The Scheme will provide for the stocking and improvement of waters and the provision of angling facilities.
