DEPARTMENT OF TRADE AND INDUSTRY WIRELESS TELEGRAPHY ACT 1967

Notice of Authority given under Section 7

Whereas

A The custody and control inter alia of certain cordless telephone apparatus are restricted by Article 4 of the Wireless Telegraphy (Cordless Telephone Apparatus) (Restriction and Marking) Order 1992 (S.I. 1992/2009) ("the Order").

B The Secretary of State is satisfied that this Authority and the terms and conditions attached to it are compatible with the international obligations of the United Kingdom ("UK").

Now Therefore

1. The Secretary of State in exercise of the powers conferred on him by section 7 of the Wireless Telegraphy Act 1967 gives authority to any person ("the Purchaser") to have in his custody and control up to 3 pieces of cordless telephone apparatus ("the Apparatus") the custody and control of which would otherwise be restricted by the Order, subject to the terms and conditions set out in paragraphs 2 to 8 below.
2. The Apparatus shall be supplied to the Purchaser by a vendor ("the Vendor") duly authorised to sell the same under the terms of an Authority issued by the Secretary of State pursuant to section 7 of the Wireless Telegraphy Act 1967.
3. The Purchaser shall be a bona fide tourist who is neither a British citizen nor resident in the UK and is purchasing the Apparatus for export.
4. The Purchaser shall leave the UK with the Apparatus within 3 months of the date of the purchase.

5. The Purchaser shall not use or sell or offer for sale the Apparatus in the UK.
6. The Purchaser shall complete and retain a valid export document form VAT 407 issued by HM Customs and Excise which has also been completed by the Vendor.
7. The Purchaser shall make the document referred to in paragraph 6 above available for inspection by duly authorised officers of the Department of Trade and Industry on demand.
8. This Authority shall remain in force until it is revoked by the Secretary of State.
9. The Interpretation Act 1978 shall apply for the purposes of interpreting this Authority as if it were an Act of Parliament.

SEEDS (FEES) REGULATIONS (NORTHERN IRELAND)
1993

Regulations controlling the marketing of cereal seeds, fodder plant seeds, beet seeds, oil and fibre plant seeds and vegetable seeds provide that, with certain exceptions, seeds of these categories may only be marketed if they are derived from crops which, on inspection, are found to meet certain standards and if upon subsequent testing samples of the seed also meet certain standards.

The above Regulations, which have been made by the Department of Agriculture for Northern Ireland under the Seeds Act (Northern Ireland) 1965, will come into operation on 5th July 1993. They prescribe revised fees for seed certification, seed testing and licences for seed testing establishments and supersede the Seeds (Fees) Regulations (Northern Ireland) 1992.

Limavady By-Pass

The Department of the Environment for Northern Ireland hereby gives notice in accordance with the provisions of Schedule 6 to the Roads (Northern Ireland) Order 1980 that it proposes to make an order under Articles 13 and 40 of the Order.

The proposed order will:

1. provide that approximately 3.5 kilometres of a proposed new road in the townlands of Rascahan, Lisnakilly, Newtown Limavady, Killane and Rathbrady More, County of Londonderry from the junction of Ballykelly Road and Farlow Road extending in a north-easterly direction to McKays Plantation, Killane and thence in a south-easterly direction to join the Broad Road approximately 170 metres east of its junction with Scriggan Road and Rathmore Road including 2 new roundabouts shall become part of the Trunk Road T7;
2. provide that approximately 4.0 kilometres of the present Trunk Road T7 shall cease to be trunk road;
3. provide for the stopping-up of part of the under-mentioned roads –
 - (a) Seacoast Road B69; and
 - (b) the unclassified road abutting the south-east of Station Car Park in Limavady;
4. provide for the stopping-up of parts of the under-mentioned roads to vehicular traffic –
 - (a) Ballykelly Road A2; and
 - (b) Seacoast Road B69.

The Department also proposes –

- (i) to construct a road bridge to carry the new road over the River Roe;
- (ii) to construct a road bridge to carry the Dowland Road over the new road;
- (iii) to construct the following roads and roundabouts:
 - (a) a link road and roundabout to connect Ballyclose Street and Main Street to the new road;
 - (b) a link road including a bridge over the Curly River to connect the Windyhill Road A2 to a roundabout on the new route at Killane;
 - (c) a road to connect Rathmore Road to the new road; and
 - (d) roads to connect Seacoast Road B69 north and south to a roundabout on the new road;

(iv) to construct the following junctions:

- (a) the junction which will exist between Farlow Road U289 and the new road on the north side; and
- (b) the junction which will exist between the Dowland Road U292 and both sides of the new link road from Windyhill Road to the proposed roundabout at Killane; and
- (v) to alter the layout and traffic priority of the junction which exists between Ballykelly Road A2, Seacoast Road B69 and Baranait Road B69.

LIMAVADY BY-PASS

In the Townlands of Rascahan, Lisnakilly, Newtown Limavady, Killane and Rathbrady More

COUNTY OF LONDONDERRY

The Department of the Environment hereby gives notice in accordance with the provisions of Article 39B of the Roads (Northern Ireland) Order 1980 as inserted by regulation 2 of the Roads (Assessment of Environmental Effects) Regulations (Northern Ireland) 1988 that it has prepared an environmental statement on the effects of the proposed Limavady By-Pass road project.

The general effect of the project will be to realign approximately 3.5 kilometres of the T7 Coleraine to Londonderry Trunk Road north of Limavady between Broad Road at Rathbrady More and Ballykelly Road at Rascahan and will include a new bridge over the River Roe adjacent to the playing fields at the College of Further Education in Limavady.

The proposed new length of trunk road is to be 9.3 metres wide and is to be carried in a cutting up to approximately 7 metres deep at Lisnakilly and Killane and on an embankment approximately 3 to 4 metres high across the River Roe flood plain.

The project also provides for approximately 900 metres of link road to connect the new trunk road at McKay's Plantation to A2 Windyhill Road at Artikelly by means of a new bridge over the Curly River and approximately 350 metres of link road to connect the new trunk road at Newtown Limavady through the former railway station yard to the eastern end of Main Street, Limavady.

In addition, some modifications will be made to existing routes. These include, a revised layout to the existing Shanreagh cross-roads, just west of the Roe Bridge. In addition, the Ballykelly Road will be stopped-up to vehicular traffic at Rascahan and the Dowland Road will be bridged over the new trunk road at Killane/Rathbrady More.

The project is intended to remove through traffic from Limavady streets thereby reducing congestion and delay.
