THE CHANNEL TUNNEL (INTERNATIONAL ARRANGEMENTS) ORDER 1993

(SI 1993 No. 1813)

This Order came into force on 2nd August 1993, the date on which the Protocol between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the French Republic concerning frontier controls and policing, co-operation in Criminal Justice, Public Safety and mutual assistance relating to the Channel Fixed Link entered into force."

MAINTENANCE OF WATERCOURSES 1993/94 (SUPPLEMENTARY LIST)

The Department of Agriculture for Northern Ireland hereby gives notice in pursuance of Regulation 5 (1) of the Drainage (Environmental Assessment) Regulations (Northern Ireland) 1991 of proposed routine maintenance works on the main watercourses listed at A below and on minor watercourses in the catchments listed at B below.

Further details of the locations along the rivers concerned are available at the Department's Watercourse Management Office at the address below.

The work may include the following:

1. Necessary removal of channel silt and/or aquatic weed growth.
2. Removal of obstructions from the channel which restrict the free flow of water.
3. General maintenance of grilles, manholes and/or flap-valves.

4. Construction, repair or protection of flood defences, revetments and watercourse structures.
5. Measures for the protection or rehabilitation of fishery, conservation, or other interests.

The Department will carry out the work using environmentally sensitive river engineering techniques.

The Department reserves the right to alter the maintenance programme.

Having determined that the proposed works are not, by reason amongst other things of their nature, size or location, likely to have significant environmental effects it is the Department's intention not to prepare an Environmental Statement.

In accordance with Regulation 5 (1) (d) of the Regulations representations may be made in writing to the Department at the address given below, with regard to its intention not to prepare an Environmental Statement. The closing date for receipt of representations is 3rd September, 1993.

The Department will consult with Conservation and Fisheries organisations on the works programme.

THE INSOLVENCY (NORTHERN IRELAND) ORDER 1989

**OFFSHORE INSTALLATIONS AND PIPELINE WORKS (FIRST-AID)
REGULATIONS (NORTHERN IRELAND) 1993**

The Department of the Environment has made a Statutory Rule under Article 3 of the Road Races (Northern Ireland) Order 1986 entitled the Road Races (Carrowdore 100) Order (Northern Ireland) 1993 (SR 1993 No. 331).

This Order permits the Belfast and District Motor Club Ltd. as promoter of the Carrowdore 100 to use for that event the roads named in the Order by suspending the right of way of other traffic between 10.30 am and 6.30 pm on 4th September, 1993.

In effect this order temporarily closes those roads.

The Department of the Environment has made a Statutory Rule entitled Road Transport Licensing (Fees) (Amendment) Regulations (Northern Ireland) 1993 (SR 1993 No. 332).

These Regulations which come into operation on 8th September, 1993 provide for an increase in the fees for road service licences, road freight operators' licences and road freight vehicle licences.

*Road Traffic and Vehicles*TEMPORARY SPEED LIMIT (ROUTE A2, BELFAST/HOLYWOOD) (No. 2)
ORDER (NORTHERN IRELAND) 1993*Made* 21st July 1993
Coming into operation 29th August 1993

Whereas the Temporary Speed Limit (Route A2, Belfast/Holywood) Order (Northern Ireland) 1993^(a) prohibits the driving of motor vehicles at a speed greater than 40 miles per hour on the lengths of road specified in the Schedule;

Whereas the Department of the Environment is satisfied that it is desirable in the interests of safety to continue to restrict the speed of motor vehicles on those lengths of road;

Now Therefore the Department, in exercise of the powers conferred on it by Article 51(4) of the Road Traffic (Northern Ireland) Order 1981^(b) and of every other power enabling it in that behalf, makes the following Order:

Citation and commencement

1. This Order may be cited as the Temporary Speed Limit (Route A2, Belfast/Holywood) (No. 2) Order (Northern Ireland) 1993 and shall come into operation on 29th August 1993.

Continuance in force of provisions of SR 1993 No. 166

2. The provisions of Article 2 of the Temporary Speed Limit (Route A2, Belfast/Holywood) Order (Northern Ireland) 1993 are hereby continued in force for a period of 4 months from 28th August 1993.

SCHEDULE

1. The northbound carriageway of Sydenham By-Pass, Route A2, Belfast, from a point approximately 120 metres south-west of its junction with Depot Road, to its junction with Belfast Road, Route A2.
2. The northbound carriageway of Belfast Road, Route A2, Belfast, from its junction with Sydenham By-Pass, Route A2, to its junction with Holywood By-Pass, Route A2, Holywood.
3. The northbound carriageway of Holywood By-Pass, Route A2, Holywood, from its junction with Belfast Road, Route A2, to a point approximately 200 metres north of that junction.
4. The southbound carriageway of Holywood By-Pass, Route A2, Holywood, from a point approximately 150 metres south-west of its junction with Sullivan Place, to its junction with Belfast Road, Route A2.
5. The southbound carriageway of Belfast Road, Route A2, Holywood, from its junction with Holywood By-Pass, Route A2, to a point approximately 50 metres north of its junction with Knocknagoney Road, Belfast.

Explanatory Note

(This note is not part of the Order)

This Order continues in force the provisions of the Temporary Speed Limit (Route A2, Belfast/Holywood) Order (Northern Ireland) 1993 (SR 1993 No. 166). It prohibits in the interests of safety for a further period of 4 months commencing on 29th August, 1993 the driving of motor vehicles at a speed greater than 40 miles per hour on part of Route A2, between Belfast and Holywood, Co. Down.

Any person who acts in contravention of the Order shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (£400).

Traffic signs indicating the effect of the Order have been erected on the road.

*Road Traffic and Vehicles*TEMPORARY SPEED LIMIT (MOTORWAY M1) (No. 2) ORDER
(NORTHERN IRELAND) 1993*Made* 30th June 1993
Coming into operation 25th July 1993

Whereas the Department of the Environment is satisfied that it is desirable in the interests of safety to restrict the speed of motor vehicles on part of the Motorway M1;

And Whereas the Department has published notice of its intention in compliance with Article 51(1) of the Road Traffic (Northern Ireland) Order 1981^(a);

Now Therefore the Department, in exercise of the powers conferred on it by Article 51(1) of the Road Traffic (Northern Ireland) Order 1981 and of every other power enabling it in that behalf, makes the following Order:

Citation and commencement

1. This Order may be cited as the Temporary Speed Limit (Motorway M1) (No. 2) Order (Northern Ireland) 1993 and shall come into operation on 25th July 1993.

Application and duration of speed limit

2. The driving of motor vehicles at a speed greater than 50 miles per hour on the lengths of road specified in the Schedule is prohibited for a period of 41 days from 24th July 1993.

SCHEDULE

1. The eastbound carriageway of the Motorway M1 from a point, Marker Post 27B31, approximately 1,900 metres east of Junction 12 (Birches), for a distance of approximately 2,850 metres in an easterly direction to a point, Marker Post 26B6.
2. The westbound carriageway of the Motorway M1 from a point, Marker Post 25A30, approximately 5,100 metres east of Junction 12 (Birches), for a distance of approximately 2,650 metres in a westerly direction to a point, Marker Post 27A19.

Explanatory Note

(This note is not part of the Order)

This Order prohibits the driving of motor vehicles on the sections of the Motorway M1 described in the Schedule at more than 50 miles per hour for a period of 41 days commencing on 25th July, 1993 in the interests of safety.

Any person who acts in contravention of the Order shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale (£400).

Traffic signs indicating the effect of the Order will in due course be erected on the road.

BUS LANES, ORMEAU ROAD, BELFAST

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by Article 21(1) of the Road Traffic (Northern Ireland) Order 1981 and of all other enabling powers made on 21st July, 1993 an order entitled The Bus Lanes (Ormeau Road, Belfast) Order (Northern Ireland) 1993 (SR 1993 No. 320) which will come into operation on 24th August, 1993.

The purpose of the Order is to prohibit vehicles other than buses or pedal cycles from entering, proceeding or waiting in bus lanes in Ormeau Road, between 8.00 am and 9.30 am from Monday to Friday, other than for the purpose of crossing the lanes and specifies the direction in which permitted vehicles may proceed in such lanes.

The Department of the Environment is planning to introduce Regulations under section 140 of the Environmental Protection Act 1990 entitled "The Environmental Protection (Refrigerants in Non-Refillable Containers) Regulations 1993."

The intention of the Regulations is to ban the import into the UK, storage and supply to the UK market of CFC, HCFC and HFC refrigerants in non-refillable (disposable) containers, except for the purposes of research and development or analysis. Regulations to ban the supply of refrigerants in these containers are needed because their use can lead to unnecessary pollution, particularly emissions of ozone depleting substances.

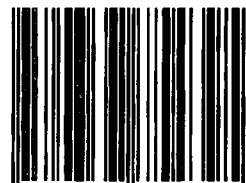
