##### *Cushendall Flood Alleviation Scheme*

The main items of work consist of:

- (a) The construction of approximately 800 m of floodwalls and floodbanks from approximately 700 m above Cushendall road bridge to 320 m below the bridge.
- (b) Regrading of the channel over the same distance including underpinning of Cushendall Bridge.

- (c) Associated pipe works from the upstream end of the car park to downstream end of the wall.

- (d) In line with Watercourse Management Divisional policy the incorporation of suitable fisheries and other appropriate conservation measures.

Having determined that the proposed works are by reason amongst other things of their nature, size or location, likely to have significant environmental effects it is the Department's intention to prepare an Environmental Statement. 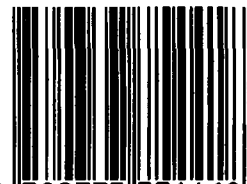
