## CONSUMER CREDIT ACT 1974

## REFUNDS OF FEES IN RESPECT OF CONSUMER CREDIT LICENCE APPLICATIONS

I, Bryan Carsberg, Director General of Fair Trading, with the approval of the Secretary of State for Trade and Industry and the Treasury; hereby give general notice pursuant to section 2(4) of the Consumer Credit Act 1974 ("the Act") as follows:

1. A refund (in full or in part) of fees paid in respect of an application for a standard licence or variation or renewal of a standard licence will be made in the following circumstances:
  - (a) where there has been an overpayment of fees, in which case the amount overpaid will be refunded;
  - (b) where the application has resulted from incorrect information provided by the Office of Fair Trading ("the Office"), in which case the full fee paid will be refunded;
  - (c) where a request for withdrawal of the application is received by the Office within two working days of the date of receipt of the application itself, in which case the full fee will be refunded;
  - (d) where a request for withdrawal of the application is received by the Office between three and fifteen working days (inclusive) of the date of receipt of the application itself, in which case half of the fee paid will be refunded.
2. This notice is effective in respect of all applications received on or after the date of this notice and supersedes general notice number 36 dated 13th March, 1991, which is hereby cancelled.

## EUROPEAN COMMUNITIES ACT 1972

The Department of Economic Development has made Regulations under the European Communities Act 1972 entitled: "Commercial Agents (Council Directive) Regulations (Northern Ireland) 1993 (S.R. 1993 No. 483)".

The Regulations, which come into operation on 13th January, 1994, implement as respects Northern Ireland Council Directive 86/653/EEC on the co-ordination of the laws of member States relating to self-employed commercial agents.

The Regulations set out the rights and obligations as between commercial agents and their principals (regulations 3 to 5) and deal with remuneration (regulations 6 to 12) and the conclusion and termination of the agency contract (regulations 13 to 16). They contain provisions relating to the indemnity or compensation payable to a commercial agent on termination of his agency contract (regulations 17 to 19) and also to the validity of restraint of trade clauses (regulation 20).

Regulation 21 makes provision regarding disclosure of information, regulation 22 makes provision with respect to the service of notice etc. and regulation 23 contains transitional provisions. The Schedule relates to persons whose activities as commercial agents are to be considered secondary.
