These tables, respectively, identify the sources of the provisions of the Orders, locate in the Orders each of the provisions of the former Companies Acts and set out the corresponding Great Britain and Northern Ireland provisions. Comparing Great Britain textbook or professional journal references is thus simplified for both professional and lay reader.
