#### CONDITIONS ATTACHED TO THIS LICENCE

- 1. Any consignment imported under the terms of this licence shall be for personal use only. (see Note 1).
- 2. Pig meat and other meat products derived from swine may not be imported from the following areas which are subject to restrictions due to the occurrence of African Swine Fever;

- (a) Sardinia, Italy;
- (b) that part of Spain from which pigmeat may not enter intra-Community trade under the terms of Council Directive 72/461/EEC (Footnote (a)) as read with Council Decision 89/21/EEC (Footnote (b)) (see Note 2); with the exception of pigmeat products which are eligible for intra-Community trade under the terms of Article 4 of Council Directive 80/215/EEC (Footnote (c)) (see Note 3).
- Products in which trade is prohibited by a declaration under Regulation 23 of the Products of Animal Origin (Import and Export) Regulations (Northern Ireland) 1993 may not be imported under this licence. (See Notes 4 and 8.)
- 4. "High risk" material, as defined in Council Directive 90/667/ EEC (Footnote (d)) may not be imported. (See Note 5.)
- 5. Products which are subject to any restrictions imposed for the purpose of protecting animal health by any Decision of the European Communities shall not be imported save as permitted by or in pursuance of such instrument. (See Note 8.)

#### NOTES:

- The fresh meat or meat product must be intended for personal consumption and not resale. If the quantity of fresh meat or meat product imported by an individual at any one time exceeds 10kg in weight the importer may be required to produce further information or evidence to support a claim that the import is for personal consumption and not resale.
- 2. The acceptable area of Spain from which pigmeat may be imported is situated to the north and east of a line formed by:
  - the river Tormes where it joins the river Douro at the border with Portugal, to Lake Embalse de Almendra, through the towns of Ledesma and Salmanca to the town of Alba de Tormes,
  - road C510 from Alba de Tormes to Anaya de Alba and Horcajo-medianero and the provincial border between the provinces of Salamanca and Avila.
  - the provincial border between Salmanca and Avila south and south-west up to where the border meets the provincial border of Caceres,
  - the provincial border between Avila and Caceres southeast up to where it meets road C110 at Puerto de Tornavacas,
  - road C110 from Puerto de Tornavacas south-west up to Jerte and Plasencia,
  - road C524 from Plasencia south to Trujillo,
  - the road from Trujillo going south through the villages of la Cumbre and Montanchez to Merida,
  - road 630 south through Torremegia and Almendralejo up to Villafranca de los Barros,
  - the road from Villafranca de los Barros east through Ribera del Fresnos, Hornachos and Campillo de Llerena to Peraleda del zaucejo and then north-east along the road to Monterrubio la Serena and Helechal until it meets the railroad at Cabeza del Buey,
  - the railway (Castuero-Puertollano) from Cabeza del Buey direction east until the railway crosses the provincial border between the provinces of Badajoz and Cordoba; the provincial border of Cordoba until it crosses the river Guadalmez,
  - the river Guadalmez in south-east direction; the provincial border between the provinces of Guidad Real and Cordoba, the river Rio de las Yeaguas in south direction and forming the provincial border between the provinces of Cordoba and Jaen; the river Guadalquivir in direction south-west from the town Villa del Rio through the towns Montoro; El Carpio, Cordoba, Almodovar del Rio, Posadas, Penaflor, Villaverde del Rio, Acolea del Rio, Sevilla and Coria del Rio until it meets the provincial border between Sevilla and Cadiz,
  - the road from the river Guadalquivir in direction southeast through the town Trebujena and Mesas de Asta to Jerez dela Frontera,
  - the road 342 direction east through the towns Arcos de la Frontera, Bornos, Villamartin, Algodonales to Olvera,

 the road from Olvera direction south-east through Estacion de Setinil to Cuevas del Becerro,

- the road from Cuevas del Becerro in direction north-east to Huertas y Montes and then in direction south-east to Ardales and further south to El Burgo,
- the road 344 from El Burgo through Alozaina to Coin,
- the road 337 from Coin through Monda, Ojen and Marbella to the Mediterranean Sea.
- 3. For the purposes of this licence fully cooked meat and meat products (including pigmeat products) in hermetically sealed containers which are on sale to the public in countries of the European Community (including Sardinia and the whole of Spain) and which can be stored at ambient temperature shall be presumed to have been produced in accordance with the requirements of Article 4 of Directive 80/215.

Hermetically sealed containers are any containers which are designed and intended to protect the contents against the entry of micro-organisms both during and after heat treatment. They include cans, glass jars and flexible pouches.

- 4. Under Regulation 23 of the Products of Animal Origin (Import and Export) Regulations (Northern Ireland) 1993, in the event of the occurrence in another country of a disease, zoonosis or other cause liable to present a serious threat to public or animal health, the Department of Agriculture for Northern Ireland may issue a declaration giving notice of the problem. Such a declaration may specify types of meat products which may not be imported from the affected country or region.
- 5. Under Council Directive 90/667/EEC the term "high risk" material includes:
  - (a) meat and products from all bovine animals, pigs, goats, sheep, solipeds, poultry and all other animals kept for agricultural production, which have died or been killed on the farm but were not slaughtered for human consumption, including stillborn and unborn animals;
  - (b) meat and products from animals other than those slaughtered for human consumption, which are killed in the context of disease control measures.
  - (c) animal by-products including blood originating from animals which show, during the veterinary inspection carried out at the time of slaughtering, signs of disease communicable to man or other animals;
  - (d) with the exception of hides, skins, hooves, feathers, wool, horns, hair, blood and similar products, all those parts of animals slaughtered in the normal way which are not presented for post mortem inspection;
  - (e) all meat, poultrymeat, fish, game and foodstuffs of animal origin which are spoiled in such a way as to present a risk to human and animal health;
  - (f) meat and products from farm animals which have died in transit other than those slaughtered for reasons of welfare;
  - (g) animal by-products containing residues of substances which may-pose a danger to human or animal health; milk, meat or products or animal origin rendered unfit for human consumption by the presence of such residues.
- 6. Nothing in this licence gives exemption from any prohibition or restriction imposed by the Imported Food Regulations (Northern Ireland) 1991, or the Medicines Acts 1968 and 1971 or by any regulations superseding or amending the same.
- 7. Any breach of any condition attached to this licence will constitute an offence against the Diseases of Animals (Northern Ireland) Order 1981.

#### THE ENVIRONMENT

The Department of the Environment has made a Statutory Rule under Article 3 of the Road Races (Northern Ireland) Order 1986 entitled the Road Races (Ulster Rally) Order (Northern Ireland) 1994 (SR 1994 No. 242).

This Order permits the Northern Ireland Motor Club Ltd. as promoter of the Ulster Rally 1994 to use for that event the roads named in the Order by suspending the right of way of other traffic between 29th and 30th July, 1994.

In effect this Order temporarily closes those roads.

The Department of the Environment has made a Statutory Rule under Article 3 of the Road Races (Northern Ireland) Order 1986 entitled the Road Races (Craigantlet Hill Climb) Order (Northern Ireland) 1994 (SR 1994 No. 248).

This Order permits the Ulster Automobile Club Ltd. as promoter of the Craigantlet Hill Climb 1994' to use for that event the roads named in the Order by suspending the right of way of other traffic between 9.00 am and 7.00 pm on 6th August, 1994.

In effect this Order temporarily closes those roads.

#### TEMPORARY SPEED LIMIT (MOTORWAY MI) (NO. 6) ORDER (NORTHERN IRELAND) 1994

Notice is hereby given that the Department of the Environment for Northern Ireland in exercise of the powers conferred on it by Article 51 (1) of the Road Traffic (Northern Ireland) Order 1981 and of all other enabling powers made on 28th June, 1994, an Order entitled Temporary Speed Limit (Motorway MI) (No. 6) Order (Northern Ireland) 1994 (S.R. 1994 No. 245) which will come into operation on 23rd July, 1994.

The purpose of the Order is to prohibit the driving of motor vehicles at a speed greater than 50 miles per hour on the eastbound carriageway of the Motorway MI from a point, Marker Post 20B18, approximately 1,050 metres east of Junction 10 (Lurgan), to a point, Marker Post 19B4, approximately 3,350 metres east of Junction 10, and on the westbound carriageway of the Motorway MI from a point, Marker Post 18A24, approximately 3,950 metres east of Junction 10, to a point, Marker Post 20A24, approximately 750 metres east of Junction 10, for a period of 30 days commencing on 23rd July, 1994, and to prohibit the driving of motor vehicles at a speed greater than 50 miles per hour on the eastbound carriageway of the Motorway M1 from a point, Marker Post 21B27, approximately 1,000 metres west of Junction 10, to a point, Marker Post 20B18, approximately 1,050 metres east of Junction 10, and on the north-east on-slip and north-west off-slip roads at Junction 10, for a period of 44 days commencing on 23rd July, 1994 in the interests of safety while roadworks are in progress.

# GAME LAW AMENDMENT ACT (NORTHERN IRELAND) 1951

The Department of the Environment has made a Statutory Rule entitled The Marketing and Use of Dangerous Substances (No.2) Regulations (Northern Ireland) 1994 (S.R. 1994 No. 223).

The regulations come into operation on 1st August, 1994.

The regulations give effect in part to Council Directive 89/677/ EEC (O.J. No. L398, 30.12.1989, p. 19) which amended Council Directive 79/769/EEC (O.J. No. L262, 27.9.76, p.201) on the approximation of the laws, regulations and administrative provisions of the member States relating to restrictions on the marketing and use of certain dangerous substances and preparations.

Regulation 4 prohibits the use of certain lead paint other than its use, under certain conditions, for the restoration or maintenance of historic buildings and their interiors or of works of art.

Regulations 5, 6 and 7 prohibit the use of mercury compounds for the impregnation of heavy-duty textiles, mercury, arsenic and organostannic compounds for the treatment of industrial waters, and DBB in a concentration of, or above, 0.1 per cent unless it is for conversion into finished products with a concentration below that level.

Regulation 8 makes it a criminal offence to contravene regulations 4 to 7, the penalty for which, on summary conviction, is a fine not exceeding  $\pounds 2,000$ . On conviction on indictment the penalty is a fine, or a term of imprisonment not exceeding 2 years, or both. The Department of the Environment has made a Statutory Rule entitled The Marketing and Use of Dangerous Substances (No.3) Regulations (Northern Ireland) 1994 (S.R. 1994 No. 224).

The regulations come into operation on 1st August, 1994.

The regulations give effect to Council Directive 91/339/EEC (O.J. No. L186, 12.7.91, p.64) which amended Council Directive 79/769/EEC (O.J. No. L262, 27.9.76, p. 201) on the approximation of the laws, regulations and administrative provisions of the Member States relating to restrictions on the marketing and use of certain dangerous substances and preparations.

Regulation 4 prohibits the marketing and use of the substance known as Ugilec 141 and of preparations and products (including plant and machinery) containing Ugilec 141, subject to exceptions in relation to certain plant and machinery in service on 18th June, 1994.

Regulations 5 and 6 prohibit the marketing and use of the substances known as Ugilec 121 or Ugilec 21, and DBBT.

Regulation 7 makes it a criminal offence to contravene regulation 4, 5 or 6, the penalty for which, on summary conviction, is a fine not exceeding  $\pm 2,000$ . On conviction on indictment the penalty is a fine, or a term of imprisonment not exceeding 2 years, or both.

The Department of the Environment has made a Statutory Rule entitled The Marketing and Use of Dangerous Substances Regulations (Northern Ireland) 1994 (S.R. 1994 No. 222).

The regulations come into operation on 1st August, 1994.

The regulations give effect to certain requirements of Council Directive 79/769/EEC (0.1. No. L262, 27.9.76, p. 201), as amended, which relate to restrictions on the marketing and use of polychlorinated biphenyls (PCBs) and polychlorinated terphenyls (PCTs). Council Directive 83/478/EEC (O.J. No. L263, 24.9.83, p.33) redesignated the Annex to the 1976 Directive as Annex 1. Council Directive 85/467 (O.J. No. L269, 11.10.85, p.56) provided for the phasing out of the use of PCBs and PCTs, and Council

Directive 89/677 (O.J. No. 398, 30.12.89, p.19) reduced the allowable concentration of PCBs and PCTs in preparations.

Regulation 2 defines "dangerous substance" as a substance which is a PCB or PCT, or a preparation (as defined in that regulation) or a waste oil with a PCB or PCT content of more than 0.005 per cent. by weight.

Regulation 3 sets out certain operations to which the regulations do not apply.

Regulation 4, read with the Schedule, prohibits the use of certain dangerous substances, subject to certain exceptions. In particular the Department is given power to except any manufacturing process by means of which a dangerous substance will cease to be a substance which is prohibited by Directive 76/769/EEC as amended and which will not in its opinion constitute a danger to health or the environment (regulation 4(2)(c)). The continued use of dangerous substances is not prohibited where the use is one included in the Schedule to these Regulations but only if the equipment, plant or fluid containing the dangerous substance was in service before 30th June, 1986 (regulation 4(2)(a)).

Regulation 5 lays down procedural requirements regarding exemptions under regulation 4(2)(c) (which relates to certain powers of the Department to approve processes).

Regulation 6 prohibits the second hand marketing, other than for disposal, of dangerous substances or equipment, plant or fluids containing them.

Regulation 7 makes it a criminal offence to contravene regulations 4 to 6, the penalty for which, on summary conviction, is a fine not exceeding £2,000. On conviction on indictment the penalty is a fine, or a term of imprisonment not exceeding 2 years, or both. It also provides that it shall be a defence for an accused person to prove that he took all reasonable steps and exercised all due diligence to avoid committing an offence.

These regulations replace, with certain amendments, the provisions of the Control of Pollution (Supply and Use of Injurious Substances) Regulations 1986, (S.I. 1986/902) which have ceased to have effect in Northern Ireland by virtue of the repeal by section 162 of, and Part IX of Schedule 16 to, the Environmental Protection Act 1990 (1990 c.43) of section 100 of the Control of Pollution Act 1974 (1974 c.40) under which they were made.
