#### H.M. TREASURY

HAITI: SANCTIONS

Paragraph 4 of United Nations Security Council Resolution 917 of 6 May 1994 ('the Resolution') strongly urges states to freeze without delay the funds and financial resources of specified Haitian individuals and to ensure that neither they nor any other funds and financial resources are made available to or for the benefit of such persons or of the Haitian military.

Paragraph 2 of EU Council Decision 94/315/CFSP of 30 May 1994 provides that EU member states shall take without delay the legislative, regulatory or administrative measures necessary to give effect to the freeze on funds and financial resources described in paragraph 4 of the Resolution and Council Recommendation 94/313/EC of 30 May 1994 contains supplementary provisions concerning the meaning and implementation of the Decision.

A list of the individuals covered by United Nations Security Council Resolution 917 was produced by the United Nations Security Council Sanctions Committee on 17 June 1994.

#### ARMAGH OBSERVATORY AND PLANETARIUM (NORTHERN IRELAND) ORDER 1994 PRICE £3.20

The draft Order repeals the Armagh Observatory and Museum Act 1791 (a public act of the former Irish Parliament), while preserving the historicity of the Observatory's origins and its mainly ecclesiastical corporation (retitled the Governors of the Armagh Observatory and Planetarium). It provides for the constitution and functions of the Governors and other matters including the making of byelaws regulating admission and charges; payment of grant by the Department of Education; and disposal of land requirements. It also removes the benfits applicable to the office formerly referred to in the 1791 Act as keeper (or astronomer and keeper) and, instead, places these at the disposal of the Governors for the support of the Observatory and Planetarium.
