REPORT OF THE STANDING COMMITTEE.

With reference to the notice which was published in the London, Edinburgh and Belfast Gazettes of the 2nd October, 1931, regarding a reference made by the Board of Trade to the Standing Committee under the Merchandise Marks Act, 1926, in respect of imported abrasive wheels, cylinders, cups, cones, discs, rollers, blocks, bricks, stones and sticks, consisting of grains of natural or manufactured abrasive bonded together with other material, the Board of Trade hereby give notice, in accordance with the provisions of Section 2, Sub-section 7, that a Report has been made by the Committee in respect of the aforesaid descriptions of goods.
