The Firearms (Amendment) (Northern Ireland) Order 1994 (1994 No. 3204 (NI 17)).

The Order which will come into operation on 15th February, 1995, is made only for purposes corresponding to those of Sections 1 and 2 of the Firearms (Amendment) Act 1994 (C.31).

Article 3 creates a new offence of possessing a firearm or imitation firearm with intent to cause fear of violence; and

Article 4 applies certain provisions of the Firearms (Northern Ireland) Order 1981 to imitation firearms".

TRAFFIC WEIGHT RESTRICTION, BOG ROAD, FORKHILL

BANN STREET, PORTADOWN (FOOTWAY)

Notice of Intention to Make an Abandonment Order
