NEWTOWNABBEY AREA PLAN

#### Modifications

The Newtownabbey Area Plan was prepared by the Department of the Environment for Northern Ireland under Part III of the Planning (Northern Ireland) Order 1991. Following publication of the Draft Plan in April 1993 a number of objections were

received and in November 1993 a Public Inquiry was held to hear these objections.

After considering the recommendations of the Planning Appeals Commission and the report of the Commissioner who conducted the Inquiry the Department issued an Interim Statement in March 1995. This statement set out those matters on which the Department had reached a decision and indicated other matters which were to be reviewed in light of the Commission's recommendations.

The Department having now conducted a review of the outstanding matters, which were the proposals for the western side of Ballyclare which primarily addressed the recommended realignment of roads N31 and N45 and having consulted the Newtownabbey Borough Council, considers that the proposals for the western side of Ballyclare as shown in the Draft Plan should now be modified.

Members of the public are invited to examine the modified proposals and the relevant map which, together with the original Draft Plan, will be exhibited during normal opening hours from Friday 5th May, 1995, to Friday 19th May, 1995 at the following locations:

Newtownabbey Borough Council Offices, The Square, Ballyclare.

Ballyclare Branch Library, The Market House, School Street, Ballyclare.

Anyone wishing to object to any of the modified proposals may do so in writing to the Divisional Planning Officer at the address below and may be notified of the Department's decision on such objection at such address as they specify.

Objections must be received not later than Friday, 9th June, 1995 otherwise they cannot be taken into consideration.

Depending on the number and content of the objections received the Department may cause a Public Local Inquiry to be held by the Planning Appeals Commission for the purposes of considering objections.

Any such Inquiry will be advertised in due course and objectors will be invited to attend.
