CONDITIONS ATTACHED TO THIS LICENCE

1. Each consignment must be accompanied by a certificate in accordance with the terms of Commission Decision 94/984/EC laying down the animal health conditions and veterinary certificates for the importation of fresh poultrymeat from certain third countries. The certificate must be signed by an official veterinarian of the Government of Hungary, stating:

- (a) details of consignment (including poultry species from which the material was derived, region of origin of the poultry, place of loading, number and nature of packages, identification details, net weight;
- (b) the name(s), address(es) and veterinary approved number(s) of the slaughterhouse(s), cutting plant(s) and cold store(s);
- (c) the name and address of the consignor and consignee in full;
- (d) the means of transport (including for containers the registration number, for aircraft the flight number and for ships the name).

2. Health attestation as follows:

I, the undersigned official veterinarian hereby certify, in accordance with the provisions of Directive 91/494/EEC:

- (a) that Hungary is free from avian influenza and Newcastle disease, as defined in the International Animal Health Code of OIE;
- (b) that the meat described above is obtained from poultry which:
 - (i) have been held in the territory of Hungary, since hatching or have been imported as day-old chicks;
 - (ii) come from holdings:
 - which have not been placed under animal health restrictions in connection with a poultry disease;
 - around which, within a radius of 10 km, there have been no outbreaks of avian influenza or Newcastle disease for at least 30 days;
 - (iii) have not been slaughtered in the context of any animal health scheme for the control or eradication of poultry diseases;
 - (iv) have not been vaccinated against Newcastle disease using a live vaccine during the 30 days preceding slaughter;
 - (v) during transport to the slaughterhouse did not come into contact with poultry suffering from avian influenza or Newcastle disease;
- (c) that the meat described above:
 - (i) comes from slaughterhouses which, at the time of slaughter, are not under restrictions due to a

suspected or actual outbreak of avian influenza or Newcastle disease and around which, within a radius of 10 km, there have been no outbreaks of avian influenza or Newcastle disease for at least 30 days;

- (ii) has not been in contact, at any time of slaughter, cutting, storage or transport with meat which does not fulfil the requirements of Directive 91/494/EEC.

3. Consignments imported directly into Northern Ireland must be:

- (a) imported through the border inspection post at Belfast Port or Belfast International Airport;
- (b) notified in advance to the official veterinarian at the border inspection post - one working day's advance notice must be given for products entering through Belfast Port and at least 6 hours notice of arrival must be given during the working day of the border inspection post at Belfast International Airport;
- (c) presented, on arrival at the border inspection post, to the official veterinarian and may not be removed from the border inspection post until the checks in accordance with Directive 90/675/EEC have been carried out to the satisfaction of the official veterinarian and all the checks have been paid for.

4. Consignments imported into Northern Ireland which have been transhipped via a port or airport elsewhere in the Community and which in accordance with Article 8.4 of Council Directive 90/675/EEC have not been subject to veterinary checks, must be accompanied by the original certificate and must be presented in accordance with paragraph 2.

5. Consignments imported into Northern Ireland which have entered the Community via a border inspection post outside Northern Ireland, in accordance with Article 10 of Council Directive 90/675/EEC must be accompanied to Northern Ireland by a copy of the original health certificate authenticated by the official veterinarian at the border inspection post of entry into the Community together with a document signed by the official veterinarian at the border inspection post of entry into the Community confirming that the veterinary checks have been carried out to his/her satisfaction.

6. All consignments to which this licence refers are subject to the terms of the Products of Animal Origin (Import and Export) Regulations (Northern Ireland) 1993 and must be made available, if so required, for inspection by an officer of the Department. The importer or his agent shall afford all assistance necessary to such an officer to enable him to carry out the inspection and the importer shall be responsible for meeting any costs of carrying out such an inspection.

NOTES

1. Fresh poultrymeat means any parts of domestic chickens and turkeys which are fit for human consumption and which have not undergone any treatment other than cold treatment to ensure its preservation; vacuum wrapped meat or meat wrapped in a controlled atmosphere must also be accompanied by a certificate described in condition 1 above.
2. If the poultry from which the meat was obtained have been vaccinated against Newcastle disease within 30 days before slaughter, the consignment cannot be sent to Member States or regions thereof which have been recognised in accordance with Article 12 of Directive 90/539/EEC. Commission Decision 92/381/EEC recognises Northern Ireland as a region free from Newcastle Disease.
3. Council Directive 90/675/EEC (as amended) laying down the principles governing the organisation of veterinary checks on products entering the Community from third countries.
4. Belfast Port and Belfast International Airport are border inspection posts pre-selected in accordance with Commission Decision 94/24/EC.
5. Nothing in this licence gives exemption from any requirement, prohibition or restriction imposed by the Imported Food Regulations (Northern Ireland) 1991, the Medicines Acts 1968 and 1971 or by any legislation superseding or amending the same.
6. Any breach of any condition attached to this licence will constitute an offence against the Diseases of Animals

(Northern Ireland) Order 1981 (as amended) and the Products of Animal Origin (Import and Export) Regulations (Northern Ireland) 1993.

7. In accordance with the Products of Animal Origin (Third Country Imports) (Charges) Regulations (Northern Ireland) 1993 charges for checks carried out on products at border inspection posts in Northern Ireland are payable before the products may be removed.

Notice of Intention to Make a Stopping-up Order
