Darragh Cross Stream, Darragh Cross

The Department of Agriculture for Northern' Ireland hereby gives Notice in pursuance of Article 12 (as amended) of the Drainage (Northern Ireland) Order 1973 that it proposes to carry out a drainage Scheme on the Darragh Cross Stream, Darragh Cross.

The Scheme is situated on the upstream end approximately 120 m due west of Darragh Cross Primary School to the downstream end where the stream meets the Carson's Dam River.

The Scheme involves improvements to the watercourse as follows:

- Replace 7 No. existing hydraulically inadequate culverts/ accommodation bridges with 600 mm diameter pipes at various locations along the length of the watercourse.
- Where necessary regrade watercourse upstream and downstream of the new culverts, with the removal of accumulated silt and weed growth.

Having determined that the proposed works are not, by reason amongst other things of their nature, size and location, likely to have significant environmental effects it is the Department's intention not to prepare an Environmental Statement.

BUS LANES, ORMEAU ROAD, BELFAST
