INVESTIGATION INTO RESIDENTIAL ESTATE AGENCY SERVICES IN SCOTLAND

Second Variation to Monopoly Reference made by the Director General of Fair Trading under Section 50(1) of the Fair Trading Act 1973

On 13th March, 1996, the Director General of Fair Trading, in exercise of his powers under section 9, 47(1) and (2), 49(1) and 50(1) of the Fair Trading Act 1973 ("the Act") referred to the Monopolies and Mergers Commission ("the Commission") the matter of the existence or possible existence of a monopoly situation in relation to the supply of residential estate agency services in Scotland.

The reference was varied on the 30th April, 1996, in response to a request from the Commission for clarification, so as to be in the form set out in the schedule annexed to that variation.

The Commission have made a second request for clarification of the terms of reference. They point out that the text of the variation made on 30th April, 1996, did not expressly mention certain words which were deleted from the reference (as can be ascertained from the schedule to the variation). Accordingly the Director General of Fair Trading, in exercise of his power under section 52 of the Act, and for the avoidance of doubt, hereby varies the reference dated 13th March, 1996, in the manner set out below so that the reference shall continue to be in the form set out in the schedule annexed to the variation dated 30th April, 1996.

After the words "The Commission shall" in the third main paragraph of the reference made on 13th March, 1996, the following words shall be substituted for the words "for the purpose of this reference":

"in investigating and reporting upon the question of whether a monopoly situation exists by virtue of section 7(1)(c) of the Act".

"in investigating and reporting upon the question of whether a monopoly situation exists by virtue of section 7(1)(c) of the Act,".

SCHEDULE

THE SUPPLY OF RESIDENTIAL ESTATE AGENCY SERVICES IN SCOTLAND MONOPOLY REFERENCE BY THE DIRECTOR GENERAL OF FAIR TRADING

The Director General of Fair Trading, in exercise of his powers under sections 9, 47(1) and (2), 49(1) and 50(1) of the Fair Trading Act 1973 ("the Act") hereby refers to the Monopolies and Mergers Commission ("the Commission") the matter of the existence or possible existence of a monopoly situation in relation to the supply of residential estate agency services.

The Commission shall investigate and report on the questions whether a monopoly situation exists in relation to such supply and, if so:

- (a) by virtue of which provisions of sections 6 to 8 of the Act that monopoly situation is to be taken to exist;
- (b) in favour of what person or persons that monopoly situation exists;
- (c) whether any steps (by way of uncompetitive practices or otherwise) are being taken by that person or those persons for the purpose of exploiting or maintaining the

monopoly situation and, if so, by what uncompetitive practices or in what other way;

- (d) whether any action or omission on the part of that person or those persons is attributable to the existence of the monopoly situation and, if so, what action or omission and in what way it is so attributable; and
- (e) whether any facts found by the Commission in pursuance of their investigations under the preceding provisions operate, or may be expected to operate, against the public interest.

The Commission shall, *in investigating and reporting upon the question of whether a monopoly situation exists by virtue of section 7(1) (c) of the Act*, limit their consideration to:

- (a) the area of Scotland; and
- (b) agreements or practices whereby solicitors who are engaged in the supply of residential estate agency services conduct their affairs as mentioned in section 7(2) of the Act by:
- (i) adhering to terms that an interest in land used for residential purposes may be advertised in a property centre only if restrictions on advertising it elsewhere are observed; or
- (ii) participating in arrangements under which persons who are engaged in the supply of residential estate agency services but who are not solicitors are not permitted to advertise an interest in land used for residential purposes in a property centre.

For the purpose of this reference:

"conveyancing services" means services comprising the preparation of writs, contracts and other documents in connection with the transfer of an interest in land used for residential purposes, and services ancillary thereto;

"dispose of an interest in land used for residential purposes" means transfer or create an interest in land used for residential purposes; and any references to disposing of or acquiring an interest in land used for residential purposes shall be construed accordingly;

"an interest in land used for residential purposes" means any estate, interest, servitude or other right in or over land in Scotland used for residential purposes:

- (a) which is capable of being owned or held as a separate interest; and
- (b) a title to which may be recorded in the Register of Sasines, or which may be registered in the Land Register of Scotland;

"a property centre" means an establishment used primarily for the purpose of providing advertising services to solicitors who are engaged in the supply of residential estate agency services, the premises of which are open to the public and have on display, or otherwise available, particulars of interests in land used for residential purposes which the solicitors using the establishment have been instructed to dispose of;

"the supply of residential state agency services" means the undertaking and performance of engagements pursuant to instructions received from another person ("the client") who wishes to dispose of an interest in land used for residential purposes:

- (a) for the purpose of, or with a view to, effecting the introduction to the client of a third person who wishes to acquire such an interest; and
- (b) after such an introduction has been effected, for the purpose of securing the disposal of that interest, excluding the supply of conveyancing services.

The Commission shall report on this reference within a period of 9 months from the date hereof.

Notice of proposed revocation of the Trade Descriptions (Place of Production) (Marking) Order 1988

1. Each consignment must be accompanied by a commercial document authorised by an official veterinary surgeon of the Government of the exporting country in accordance with Article 3(4)(iii) of Council Directive 92/45/EEC on public health and animal health problems relating to the killing of wild game and the placing on the market of wild game meat.

Transshipment

2. All consignments which transit via a third country must be accompanied by a health certificate issued by an authorised veterinary officer of the exporting country stating:
 - (a) the details of consignment (species, nature of cuts, nature of packaging, number of packages, net weight);
 - (b) the address(es) and veterinary approval number(s) of the slaughterhouse(s); address(es) and veterinary approval number(s) of the approved cutting premises;
 - (c) the destination of the wild game meat (place of loading, country and place of destination, names and addresses of consignor and consignee means of transport, (for railway wagons or goods vehicles the registration number should be given, for aircraft the flight number and for ships the name));
 - (d) the following health attestation:

"I the undersigned official veterinarian certify that the wild game meat described above was obtained under the conditions governing production and control laid down in Directive 92/45/EEC and -

 - (i) is intended for a Member State after transit through a third country;
 - (ii) has been passed as fit for human consumption following a veterinary inspection carried out in accordance with Directive 92/45/EEC (');
 - (iii) the transport vehicles or containers and the loading conditions of this consignment meet the hygiene requirements laid down in that Directive".
3. The importer or his agent must report to the local Divisional Veterinary Office by the quickest practicable means the arrival/anticipated arrival of each consignment.
4. The importer or his agent must immediately notify the local Divisional Veterinary Office of any irregularity in the consignment or accompanying documentation.
5. All consignments of products to which this licence refers are subject to the terms of the Products of Animal Origin (Import and Export) Regulations (Northern Ireland) 1993, and any product imported under this licence shall be made available, if so required, for inspection by an officer of the Department. In particular the provisions of Regulation 8(3)

Article 18 which provides for the restriction of street works following substantial road works;

Article 26 which requires undertakers executing street works to carry on and complete their works without unnecessary delay or obstruction;

The above Code of Practice will come into effect in Northern Ireland on 25th June, 1996 and is approved for the purpose of providing practical guidance with respect to the Construction (Design and Management) Regulations (Northern Ireland) 1995 (S.R. 1995 No. 209), Articles 4, 5 and 7 of the Health and Safety at Work (Northern Ireland) Order 1978, the Management of Health and Safety at Work Regulations (Northern Ireland) 1992 and the Provision and Use of Work Equipment Regulations (Northern Ireland) 1993.

Withdrawal of Approval

Under the terms of Article 18(5) of the Health and Safety at Work (Northern Ireland) Order 1978, the Agency withdraws its approval with effect from 25th June, 1996, to the GB Approved Code of Practice entitled "Managing Construction for Health and Safety (L54) (ISBN 0 7176 0792 5)."

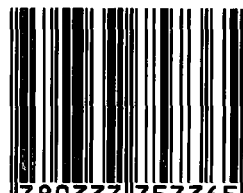
