TRADE DESCRIPTIONS ACT 1968

Notice of proposed revocation of The Trade Descriptions (Sealskin Goods) (Information) Order 1980

1. Notice is hereby given pursuant to section 38(3)(a) of the Trade Descriptions Act 1968 that the Secretary of State for Trade and Industry intends to make an Order under section 38(1) of that Act to revoke the Trade Descriptions (Sealskin Goods) (Information) Order 1980.
2. The effect of the Order will be to remove the requirement, imposed by the 1980 Order, for information to be given in respect of goods made of sealskin, including information in certain advertisements for the supply to retail customers of sealskin goods.

Notice is hereby given that the Department has made a Statutory Rule entitled Disclosure of Interests in Shares (Amendment) Regulations (Northern Ireland) 1996 (S.R. 1996 No. 246) which comes into operation on 15 July, 1996.

These Regulations make provision for disregarding, for the purposes of the disclosure of interests in shares pursuant to Articles 206 to 210 of the Companies (Northern Ireland) Order 1986, certain interests in shares arising from arrangements effected under the computer-based system for the transfer of title to securities otherwise than by a written instrument where the operator of the system is approved by the Treasury under the Uncertificated Securities Regulations 1995.

DEPARTMENT OF THE ENVIRONMENT

GAME PRESERVATION ACT (NORTHERN IRELAND) 1928 AND GAME LAW AMENDMENT ACT (NORTHERN IRELAND) 1951

Notice is hereby given that the Department of the Environment on 11th June, 1996, made an Order under the above-mentioned Acts entitled: Game Birds Preservation Order (Northern Ireland) 1996.

This Order prohibits:

1. the sale or purchase of grouse for consumption in Northern Ireland or elsewhere by human beings or animals at any time from 11th August, 1996 to 11th August, 1997;
2. the killing or taking of partridge, red-legged partridges or hen pheasants at any time from 30th September, 1996 to 30th September, 1997, except where exemption is granted by the Department;
3. the sale or purchase of partridge, red-legged partridges or hen pheasants for consumption in Northern Ireland or
