1932 REVIEW OF THE OPERATION
OF THE RAILWAY FREIGHT
REBATES SCHEME

NOTICE is hereby given that the Railway Rates Tribunal will sit at 10-30 a.m. on Wednesday, the 16th November, 1932, in Court "A," Judges' Quadrangle, Royal Courts of Justice, London, W.C.2, to review the operation of the Railway Freight Rebates Scheme for the year ending 30th September, 1932, pursuant to the provisions of Part I of the Eleventh Schedule to the Local Government Act, 1929.

Notice is also given that the Railway Companies to which the said Scheme applies have filed with the Tribunal an Application (1932, No. 15), pursuant to the provisions of subparagraph 1 (a) of paragraph 5 of the said Part I of the Eleventh Schedule that in respect of the year 1st October, 1932, to 30th September, 1933, the sum to be paid out of the general monies of the Railway Freight Rebates Fund in respect of administrative expenses shall be increased from one-half of one per cent to one per cent. or such additional percentage of the aggregate of the estimated rate relief of the said Companies in that year as will yield a sum amounting to £43,000; which Application will also be heard at the above-mentioned time and place.

Notice is further given that Accounts and Statements relative to such review have been lodged with the Tribunal. Any Railway Company to which the said Scheme applies or Representative Body of Traders Interested, which may be desirous of being heard before the Tribunal on the Review must file a Notice of such desire, and any person desiring to object to the aforesaid Application must file a separate Notice of Objection at the Office of the Registrar, 2 Clement's Inn, London, W.C.2, on or before Monday, the 7th day of November, 1932.

Such Notices must be on foolscap size paper, and must state concisely the Submission (if any) which is desired to be made, and in the case of an Objection the nature and grounds thereof. A Notice by a Representative Body

of Traders must in addition contain a statement of the facts upon which such Body claims to represent a substantial number of persons interested in any or all of the selected traffics.

Each Notice filed must be stamped with an adhesive fee stamp for 2s. 6d. (which can be purchased at the office of the Tribunal only). If sent by post each Notice must be accompanied by a Postal Order for 2s. 6d., payable to the Registrar, Railway Rates Tribunal, when a stamp will be affixed at the office. TRADE BOARDS ACT (NORTHERN IRELAND), 1932.

LINEN AND COTTON HANDKERCHIEFS AND HOUSEHOLD GOODS AND LINEN PIECE GOODS TRADE BOARD (NORTHERN IRELAND).

The Trade Board established by the Ministry of Labour for Northern Ireland under powers conferred by the Trade Boards Act (Northern Ireland), 1923, for the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Trade in Northern Ireland as defined in the Schedule to the Trade Boards (Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Trade, Northern Ireland) (Constitution, Proceedings and Meetings) Regulations, 1924, dated the 17th November, 1924, hereby give notice that they propose (a) to fix and to vary certain piece-work basis time-rates for male workers employed on Swiss Embroidery Machines; (b) to fix certain additional general minimum piece-rates for female workers; and (c) to vary and/or fix corresponding general overtime rates.

On request to the Trade Board particulars of the proposed minimum rates and variation of minimum rates and information as to their application will be given if, in the opinion of the Trade Board, the applicant is likely to be affected thereby.

The Trade Board will consider any objections to their proposals which may be lodged with them within one calendar month from the 21st day of October, 1932, in the case of their proposal to fix minimum rates, and within fourteen days from the 21st day of October, 1932, in the case of their proposal to vary minimum rates. Such objections should be in writing and signed by the person making the same (adding his or her full name and address), and should be sent to the Secretary of the Linen and Cotton Handkerchief and Household Goods and Linen Piece Goods Trade Board (Northern Ireland), Office of Trade Boards, Stormont, Belfast. It is desirable that persons making objections should state, as far as possible, the precise grounds therefor.

Merchandise Marks (Imported Goods) Exemption Direction (No. 1), 1932.

In accordance with the provisions of Section 3, Sub-Section (2) of the Merchandise Marks Act, 1926, the Board of Trade give notice that in pursuance of the powers conferred upon them by the said Section 3, they have given a Direction in the following terms:—

Whereas by Section 3, Sub-Section (1) of the Merchandise Marks Act, 1926 (16 & 17 Geo. V., c. 53), it is provided that if, where an Order in Council has been made under that Act with respect to any goods, it is shown to the satisfaction of the appropriate Department by persons appearing to the Department to have a substantial interest in the matter that the application of the provisions of the Order or of some of those provisions to any particular class or description of those goods has caused or is likely to cause injury or hardship to the said persons or any of them, the Department may direct that the Order or any particular provisions of the Order shall cease to apply to goods of that class or description or shall apply

to such goods subject only to such modifications and conditions as the Department think fit, and the Order shall, while Direction is in force, have effect subject thereto;

And whereas it is provided inter alia by Article 1 of the Merchandise Marks (Imported Goods) No. 8 Order, 1932,* that it shall not be lawful to sell or expose for sale in the United Kingdom any imported toys unless they bear

an indication of origin;

And whereas the Board of Trade, being the Appropriate Department in this case, having considered representations made to them in that behalf by persons appearing to the Board to have a substantial interest in the matter, are satisfied that the application of the aforesaid provisions of Article 1 of the said Order to toys in the possession of the said persons prior to the 1st June, 1932, is likely to cause

hardship to the said persons:

Now, therefore, the Board of Trade in pursuance of the powers conferred upon them by the said Section 3 hereby direct as follows:

1. The Merchandise Marks (Imported Goods) No. 8 Order, 1932, shall not apply to any toy when sold or exposed for sale by any person before the 1st January, 1933, provided that such toy is proved to have been in the possession of such person before the 1st June, 1932.

2. This Direction may be cited as the Merchandise Marks (Imported Goods) Exemption Direction (No. 1), 1932.
