An 'on-site' service is a radio system with a limited operating area normally up to 3 km in radius from a specified location.

GENERAL IMPORT LICENCE

The Department of Agriculture for Northern Ireland, in accordance with the terms of the above legislation, hereby authorises the landing in Northern Ireland of:

Product:

Fishmeal (bagged or bulk) including meal of sea animals with the exception of mammals and products including mixtures, other than petfood containing these products;

from

Country of Origin: Iceland;

subject to the following conditions:

- 1. Where the consignment:
 - (i) originates from an establishment approved in accordance with Council Directive 90/667/EEC (Note 1), it must be accompanied by a commercial document indicating the approval number of the establishment of production and the nature of the product;

Or

(ii) originates from an establishment registered in accordance with Council Directive 90/667/EEC, it must be accompanied by a health certificate issued and signed by an official veterinarian showing the registration number of the establishment of production, the methods of treatment used on the consignment, and the result of the salmonella tests carried out.

2. Sampling

- (a) Any material imported under this licence must be made available, if so required, for inspection and/or sampling by an officer of the Department of Agriculture. The importer or his agent shall afford all assistance necessary to such an officer to enable him/her to carry out the sampling.
- (b) Where the result of sampling carried out under 2(a) above gives a positive result, the Department of Agriculture may require the consignment to be reexported, subjected to further processing, destroyed or diverted to a use other than the feeding of livestock.
- 3. Consignments imported directly into Northern Ireland must
 - (a) imported through the border inspection post at Belfast Port or Belfast International Airport;
 - (b) notified in advance to the official veterinarian at the border inspection post - one working day's advance notice must be given for products entering through Belfast Port and at least 6 hours' notice of arrival must be given during the working day of the border inspection post at Belfast International Airport;

- (c) presented on arrival at the border inspection post, to the official veterinarian and may not be removed from the border inspection post until the checks in accordance with Directive 90/675/EEC (Note 2) have been carried out to the satisfaction of the official veterinarian and all the checks have been paid for.
- 4. Consignments transhipped to Northern Ireland via a port or airport elsewhere in the Community and which in accordance with Article 8.4 of Council Directive 90/675/EEC have not been subject to veterinary checks must be accompanied by the original documentation and must be presented in accordance with paragraph 3 above.
- 5. Consignments which have entered the Community via a border inspection post outside Northern Ireland, in accordance with Article 10 of Council Directive 90/675/EEC must be accompanied to Northern Ireland by a copy of the original documentation authenticated by the official veterinarian at the border inspection post of entry into the Community, together with a document signed by the official veterinarian at the border inspection post of entry into the Community confirming that the veterinary checks have been carried out to his/her satisfaction.
- 6. This licence will remain valid until further notice or unless the licence is revoked by the Department.
