#### **TREASURY**

#### VALUE ADDED TAX

Treasury Direction dated 20 July 1998 under section 41(3) of the Value Added Tax Act 1994 as to the refund to Government departments of tax charged on the supply of goods or services or on the acquisition or importation of goods by them otherwise than for the purpose of any business carried on by them or on a supply of goods or services by them treated as a supply in the course or furtherance of a business.

The Treasury, in exercise of the powers conferred on them by section 41(3) of the Value Added Tax Act 1994 (1994 c. 23), hereby direct as follows:

- 1. This direction shall come into operation on 24 July 1998.
- Subject as provided in paragraph 3, a Government department listed in or belonging to a category of departments listed in List 1 of this direction may claim and be paid a refund of the tax charged on:
  - (a) the supply to it of any services of a description in List 2.
  - (b) the supply to it of leased accommodation for more than 21 years as part of the supply to it of any services of a description in List 2; or
  - (c) the supply to it or acquisition from another Member State or importation from outside the Member States by it of goods closely related to the supply to it of any services of a description in List 2.
- 3. A tax refund as described in paragraph 2 will only he paid if:
  - either the supply of those services or goods is not for the purpose of:
    - (i) any business carried on by the department; or
    - (ii) any supply by the department which, by virtue of directions made under section 41(2) and (5) of the Value Added Tax Act 1994, is treated as a supply in the course of furtherance of a business; and
  - (b) the department complies with the requirements of the Commissioners of Customs and Excise both as to the time, form and manner of making the claim and also on the keeping, preservation and production of records

relating to the supply, acquisition or importation in question.

 The Treasury Direction dated 1 September 1997 is hereby revoked.

#### PROPOSED MODIFICATIONS OF THE LICENCES OF MERCURY PERSONAL COMMUNICATIONS LIMITED AND ORANGE PERSONAL COMMUNICATIONS SERVICES LIMITED

- 1. The Director General of Telecommunications ("the Director"), in accordance with section 12(2) of the Telecommunications Act 1984 ("the Act"), hereby gives notice that he proposes to make modifications to the licence granted to Mercury Personal Communications Limited ("MPCL") on 9th May, 1995 and to the licence granted to Orange Personal Communications Services Limited ("OPCL") on 27th July, 1995.
- 2. Modifications were made to the licences of MPCL and OPCL on 2nd April 1998, to remove the obligations contained in those licences to provide airtime to mobile service providers subject to a transitional period of one year from the date the modifications were made. At the same time changes were made to the licences, the effect of which was to remove the obligations under section 8(1) of the Act to publish charges and not to show undue preference or discrimination in respect of some of the services which the Licensees are obliged to provide under the licences. The Director now proposes to make the modifications described in the Schedule below in order to restore these obligations which are necessary to ensure that section 8 of the Act applies to the licences of MPCL and OPCL.
- 3. The proposed modifications apply to the telecommunications services which the licensees are currently obliged to provide. The position relating to other services will be subject to review as part of the implementation of the Directive 97/13 EC of the European Parliament and Council ("the Licensing Directive") on which the Department of Trade and Industry propose to issue a consultation document later this year.
- 4. The Director is required by section 12(2) of the Act to consider any representations or objections which are duly made and not withdrawn. Subject to such considerations and the consent of MPCL and OPCL, the Director proposes to make the modifications forthwith.
- 5. The consultation procedure comprises two stages. In the first stage, representations on or objections to the proposed modifications may be made to Rosemary Buck, OFTEL, 50 Ludgate Hill, London EC4M 7JJ (telephone 0171-634 8822, fax 0171-634 8847) by no later than Friday, 21st August, 1998.
- It is OFTEL's usual practice to have a two stage consultation, where the second stage of the consultation is for the purpose of providing comments on the responses to the consultation itself.

However on this occasion, in view of the technical nature of these modifications which serve only to remedy a possible defect in the modifications made on 2nd April 1998, it is not intended that a further period of 14 days will be granted.

#### THE SCHEDULE

It is proposed to modify the licences as follows:

Condition 8 (Prohibition of charges, terms and conditions to be applied – by applying the obligation to publish charges to services which the licensees are currently obliged to provide under their licence: and

Condition 9 (Prohibition on undue preference and undue discrimination) – by applying the prohibition on undue preference and undue discrimination to services which the licensees are currently obliged to provide under their licences.

Application for Fish Culture and Shellfish Fishery Licences

#### SUSPENSION FROM WORK ON MATERNITY GROUNDS (MERCHANT SHIPPING AND FISHING VESSELS) ORDER (NORTHERN IRELAND) 1998

Notice is hereby given that the Department of Economic Development, in exercise of the powers conferred on it by Article 98(2) of the Employment Rights (Northern Ireland) Order 1996 and of every other power enabling it in that behalf, has made a Statutory Rule entitled the Suspension from Work on Maternity Grounds (Merchant Shipping and Fishing Vessels) Order (Northern Ireland) 1998 (S.R. 1998 No. 242).

Regulations 8(3) and 9(2) of the Merchant Shipping and Fishing Vessels (Health and Safety at Work) Regulations 1997 ("the 1997 Regulations") require that in certain circumstances new or expectant mothers shall be suspended from work for health and safety reasons.

Articles 99 and 100 of the Employment Rights (Northern Ireland) Order 1996 ("the 1996 Order") provide that before an employee is suspended from work on maternity grounds she has the right to be offered alternative work, and if she is suspended she has the right to be paid during the period of suspension. Under Article 98 of the 1996 Order, an employee is suspended on maternity grounds if she is suspended under a provision for the

time being specified in an Order made by the Department of Economic Development.

This Order specifies regulations 8(3) and 9(2) of the 1997 Regulations, so that suspension under those provisions constitutes suspension on maternity grounds.

In this way, Articles 5(2), 5(3) and 7(2) of Council Directive 92/85/EEC on the introduction of measures to encourage improvements in the safety and health of pregnant workers and workers who have recently given birth or are breastfeeding (OJ No. L 348, 28.11.92, p.1) are given similar effect in relation to women employed at sea as they have in relation to women employed on land in Northern Ireland.

This Order comes into operation on 16th August, 1998.

ALTERATION No. 1 - ARMAGH COUNTRYSIDE PROPOSALS

Countryside Policy Area (CPA) and Small Settlements

Paragraph A. I details the circumstances in which development is not permitted.

Paragraph A.2 imposes conditions on the permitted development.

Paragraph A.3 provides definitions of terms used in Part 17. The main change made to this Part are -

- (a) development is not permitted if the installation, alteration or replacement of apparatus (other than an antenna) on a mast would result in any increase in the specified height limits (Paragraph A.1(e));
- (b) the introduction of a prior notification procedure which makes the permitted development conditional upon the telecommunications code system operator applying to the Department for a determination as to whether the Department's prior approval is required to the siting and appearance of the proposed development (Paragraph A.2(4)(i));

the application must be accompanied by a written description of the proposed development, a plan indicating its proposed location and the appropriate fee (Paragraph A.2(4)(ii) and (iii));

the Department has 28 days in which to make and notify its determination on whether prior approval is required to the siting and appearance and to give or refuse such approval (Paragraph A.2(4)(iv)); and

(c) the extension of the sensitive areas in which permitted development rights are not exercisable to include areas of special scientific interest (Paragraph A.1 (i), (k), (m) and (n)). Part 18 grants permission for the installation alteration or replacement of a microwave antenna on a building or structure. Development under this Part is not restricted to telecommunications code system operators.

Class A permits the installation, alteration or replacement of a microwave antenna on a building or structure 15 metres or more in height.

Paragraph A.1 details circumstances in which the development is not permitted. The main change is that the maximum size limit for the antenna has been increased from 90 centimetres to 1.3 metres (Paragraph A.1( $^d$ ));

Paragraph A.2 imposes conditions on the permitted development.

This Order adds Class B to Part 18 which permits the installation, alteration or replacement of a satellite antenna on a building or structure less than 15 metres in height.

Paragraph B.1 details circumstances in which development is not permitted. B.10 restricts the size of the antenna, measured in any dimension to 90 centimetres.

Paragraph B.2 imposes conditions on the permitted development.
