ORDER OF THE SECRETARY OF STATE

CIVIL SERVICE (AMENDMENT) (NORTHERN IRELAND) ORDER 1998

In exercise of the powers conferred on me by Letters Patent of Her Majesty dated 20th December, 1973 and of all other powers enabling me in that behalf, I hereby make the following Order:

Title and commencement

- This Order may be cited as the Civil Service (Amendment) (Northern Ireland) Order 1998 and shall come into operation forthwith
- The Interpretation Act (Northern Ireland) 1954 (a) shall apply to this Order as it applies to a Measure of the Northern Ireland Assembly.

General Regulations

- In Article 5 of the Civil Service Order (Northern Ireland) 1996(b).
 - (a) for paragraph (2)(b) there shall be substituted-
 - "(b) by any relevant member for the purpose only of providing advice to him during a period terminating on or before the dissolution of the New Northern Ireland Assembly"; and
 - (b) after paragraph (2) there shall be added-
 - "(3) In paragraph (2)(b) "relevant member" means any of the following persons, that is to say-
 - the Presiding Officer of the New Northern Ireland Assembly;
 - (b) the First Minister or Deputy First Minister of that Assembly; or
 - (c) any other Minister of that Assembly.".

EXPLANATORY NOTE

(This note is not part of the Order)

The Civil Service (Northern Ireland) Order 1996 ("the 1996 Order") provides that the Department of Finance and Personnel ("the Department") shall continue to be responsible for the general management and control of the Northern Ireland Civil Service ("the Civil Service"). The 1996 Order lays down the functions of the Northern Ireland Civil Service Commissioners ("the Commissioners"). It provides in Article 5(1), subject to the exceptions in Article 5(2), that the Commissioners may, with the approval of the Department, make General Regulations prescribing the manner by which persons shall be selected for appointment to a situation in the Civil Service.

This Order amends the 1996 Order by deleting the exception for appointments to a situation in the Civil Service made by the head of a Northern Ireland department and substituting appointments to a situation in the Civil Service made by the Presiding Officer of the New Northern Ireland Assembly, the First Minister, the Deputy First Minister and any other Minister of the New Northern Ireland Assembly.



Fire Services (Amendment) (Northern Ireland) Order 1998 (S.I. 1998 No. 1549 (N.I. 11)) - Price £1.10.

The Order amends the Fire Services (Northern Ireland) Order 1984 (S.I. 1984 No. 1821 (NI. 11)) to:

- (a) bring Northern Ireland into line with Great Britain as regards dealing with fires at sea;
- (b) enable the Department to consolidate the existing Firemen's Pensions Scheme in Northern Ireland by providing a specific power for determining appeals; and
- (c) change the Constitution of the Fire Authority for Northern Ireland by replacing the exclusive nomination rights of Belfast City Council and the Association of Local Authorities of Northern Ireland (ALANI) with an obligation on the Department to appoint a minimum of 8 district councillors following consultation with all district councils and associations representative of those councils (for example, ALANI).
