PNEUMOCONIOSIS ETC., (WORKERS' COMPENSATION) (PAYMENT OF CLAIMS) (AMENDMENT) REGULATIONS (NORTHERN IRELAND) 1998

Notice is hereby given that in pursuance of powers conferred on it by Articles 2(2), 3(3), 4(3) and 11(1) and (4) of the Pneumoconiosis, etc., (Workers' Compensation) (Northern Ireland) Order 1979, ("the Order"), the Department of Economic Development has made Regulations entitled the Pneumoconiosis etc., (Workers' Compensation) (Payment of Claims) (Amendment) Regulations (Northern Ireland) 1998 (S.R. 1998 No. 358).

These Regulations, which come into operation on 29th November 1998, amend the Pneumoconiosis etc., (Workers' Compensation) (Payment of Claims) Regulations (Northern Ireland) 1998, as amended, so as to increase the amount payable under the Order. The increase in each case is 4.9%, rounded up or down to the nearest £1 as appropriate.

Under the Order, lump sum payments may be made to certain persons disabled by one of the diseases to which the Order applies. The diseases are: pneumoconiosis, byssinosis, diffuse mesothelioma, primary carcinoma of the lung (where accompanied by asbestosis or diffuse pleural thickening) and diffuse pleural thickening.

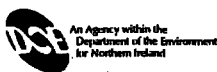

MODIFICATION OF EXPERIMENTAL TRAFFIC CONTROL SCHEME ONE-WAY TRAFFIC, LONDONDERRY

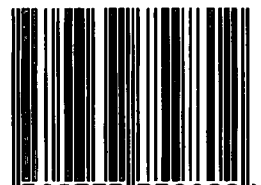
