The Order applies a 20 mph speed limit to roads and lengths of road in the Ardoyne and Ballymurphy areas of Belfast; a 40 mph speed limit to parts of Portadown Road, Armagh; Broughshane Road, Galgorm Road and Raceview Road, Ballymena; Hillhead Road and Moyola Road, Castledawson; Bells Lane, Belsize Road, Hillsborough Road and Sprucefield Roundabout, Lisburn and Coolkeeran Road, Loughguile; restricts to 30 mph the speed limit on part of Old Road, Mayobridge and de-restricts part of Raceview Road, Ballymena.

made on 21st December 1998 the Off-Street Parking (Amendment No. 6) Order (Northern Ireland) 1998 (S.R. 1998 No. 452) which will come into operation on 11th January 1999.

The Order—

- imposes the conditions of use specified in the Off-Street Parking Order (Northern Ireland) 1997 on the car parks at Dunsilly Roundabout, Antrim, and Anne Street East, Dungannon;
- introduces charging Monday to Saturday in the car parks at Harrier Way and Market Square, Ballyclare, and Anne Street East, Dungannon;
- allows buses to park in the car park at Railway Station, Limavady;
- makes provision for season tickets within tariff TPB (Park and Ride); and
- amends the Order to remove reference to the car parks at 24-30 Ormeau Avenue, Belfast, and Main Street, Toome as they have now closed, and change the name of the car park currently called Anne Street, Dungannon.

made on 22nd December 1998 the On-Street Parking (Amendment) Order (Northern Ireland) 1998 (S.R. 1998 No. 454) which will come into operation on 1st March 1999. The Order amends Parts 1 and 3 of Schedule 1 to the On-Street Parking Order (Northern Ireland) 1998 by the addition of the items in the Schedule and changes the hours of operation for parking places at Donegall Quay, Dublin Road (West Side), Great Victoria Street, from Hope Street to Fisherwick Place and Oxford Street (West Side), from Ann Street to Townhall Street.

AMENDMENTS AND ADDITION TO THE EUROPEAN PHARMACOPOEIA

The Health Ministers, that is to say the Secretaries of State concerned with health in England, in Wales and in Scotland respectively, and the Department of Health and Social Services for Northern Ireland, acting jointly, hereby declare under section 65(7) of the Medicines Act 1968 that on and after 1st February 1999, the amendments and addition to the Third Edition of the European Pharmacopoeia referred to in the Schedule hereto, are to have effect for the purposes of section 65 of the said Act.

SCHEDULE

Amendments

The monographs for Alanine (1997: 0752), Arginine (1997: 0806), Arginine Hydrochloride (1997: 0805), Aspartic Acid (1997: 0797), Cysteine Hydrochloride Monohydrate (1997: 0895), Cystine (1997: 0998), Glutamic Acid (1997: 0750), Histidine (1999: 0911), Histidine Hydrochloride Monohydrate (1997: 0910), Isoleucine (1997: 0770), Lactitol Monohydrate (1999: 1337), Leucine (1997: 0771), Lysine Hydrochloride (1997: 0930), Methionine (1997: 1027), Phenylalanine (1997: 0782), Proline (1997: 0785), Serine (1997: 0788), Sodium Valproate (1999: 0678), Threonine (1997: 1049), Tryptophan (1999: 1272), Tyrosine (1997: 1161) and Valine (1997: 0796), adopted by the European Pharmacopoeia Commission on 18th November 1998, are to have effect in replacement for the monographs contained in the Third Edition of the European Pharmacopoeia, published under the direction of the Council of Europe (Partial Agreement) in accordance with the Convention on the Elaboration of a European Pharmacopoeia.

GENERAL IMPORT LICENCE

The Department of Agriculture for Northern Ireland, in accordance with the above legislation, hereby authorises the landing in Northern Ireland of:

Product: Meat products (excluding poultry meat and game meat products) (also excluding pig meat products from Romania and Slovenia and pig and soliped meat products from Uruguay)

Country of Origin: Australia, Romania, Slovenia, Uruguay, USA
subject to the following conditions:

1. Each consignment must be accompanied by a certificate in accordance with the terms of Commission Decision 97/221/EC (see Note 1) made under Council Directive 72/462/EEC (as amended) signed by an official veterinarian of the Government of the exporting country stating:

(i) the details of consignment (animal species, description of meat products, nature of pieces, nature of packaging, number of pieces or packages, required storage and transport temperature, storage life, net weight);

(ii) the address(es) and veterinary approval number(s) of the establishment(s) supplier(s) of fresh meat, the meat products establishment(s), the storage establishment(s);

(iii) the destination of meat products (place of loading, country and place of destination), means of transport (for railway wagons or goods vehicles the registration number should be given; for aircraft the flight number; for ships the name; for lorries the registration number should be given; for bulk containers the container number and the seal number should be given), names and addresses of consignor and consignee;

(iv) that:-

"I, the undersigned, official veterinarian, certify that:

(a) The meat product contains the following meat constituents and meets the criteria indicated below:

Origin ⁽³⁾: _____

Animal Health Conditions ⁽⁴⁾: _____

(b) Where the meat product has undergone a treatment other than heating in a hermetically sealed container to an Fo value of 3.0 or more, it has been prepared from fresh meat which:

In the case of fresh meat from bovine, ovine, caprine, porcine or soliped animals:

– satisfies the animal health requirements laid down in Article 14, 15 and 16 of Council Directive 72/462/EEC and is in accordance with Commission Decision .../EEC ⁽⁵⁾; and/or

– originates in a Member State of the European Community and satisfies the requirements of Article 21a, paragraph 1, second indent, of Council Directive 72/462/EEC ⁽⁵⁾; and/or

– meets any requirements agreed under the provisions of Article 21a, last sentence, of Council Directive 72/462/EEC and has undergone the treatment laid down for the meat of the species concerned in Parts II or III (as appropriate) of the Annex to Decision 97/222/EC (see Note 2).

(c) The meat product:

– consists of meat and/or meat products derived from a single species, and has undergone the treatment satisfying the relevant conditions laid down in the Annex to Commission Decision 97/222/EC ⁽⁵⁾; or

– consists of meat from more than one species where, after mixing the meats together, the entire product has subsequently undergone a treatment which was at least equal to the most severe treatment required for any of the individual meat components contained in the meat product, as laid down in the Annex to Commission Decision 97/222/EC ⁽⁵⁾; or

– has been prepared from meat from more than one species where each of the constituent meats had previously undergone a treatment prior to mixing which satisfied the relevant treatment requirements for meat from that species, as laid down in the Annex to Decision 97/222/EC.

(d) After treatment all precautions to avoid contamination have been taken.

2. Consignments imported directly into Northern Ireland must be:-

(a) imported through the border inspection post at Belfast Port or Belfast International Airport;

(b) notified in advance to the official veterinarian at the border inspection post – one working day's advance notice must be given for products entering through Belfast Port (Tel 01232 547103) and at least 6 hours' notice of arrival must be given during the working day of the border inspection post at Belfast International Airport (Tel 01849 452577);

(c) presented, on arrival at the border inspection post, to the official veterinarian and may not be removed from the border inspection post until the checks in accordance with Directive 90/675/EEC (see Note 3) have been carried out to the satisfaction of the official veterinarian and all the checks have been paid for.

3. Consignments imported into Northern Ireland which have been transhipped via a port or airport elsewhere in the Community and which in accordance with Article 8.4 of Council Directive 90/675/EEC have not been subjected to veterinary checks must be presented in accordance with paragraph 2(c) above.

4. Consignments which have entered the Community via a border inspection post outside Northern Ireland in accordance with Article 11.2 (A) of Council Directive 90/675/EEC must be accompanied to Northern Ireland by a copy of the original certificate authenticated by the official

veterinarian at the border inspection post of entry into the Community together with a document signed by the official veterinarian at the border inspection post confirming that the veterinary checks have been carried out to his/her satisfaction.

5. The importer or his agent must immediately notify the local Divisional Veterinary Office of any irregularity in the consignment or accompanying documentation.

6. This licence revokes and replaces licence number DANI/GEN/94/26, DANI/GEN/94/27, and DANI/GEN/94/28 dated 6 October 1994.

7. This licence will remain valid until further notice or unless the licence is revoked by the Department.

(4) Insert the reference number of the relevant Community Decision (where appropriate) which was applicable to the production of the meat used in the manufacture of the meat product described in this certificate.

(5) Delete as appropriate.

(6) The colour of the seal and the signature must be different from the colour of the printing.

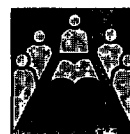
