

BANBRIDGE FLOODWALL DRAINAGE SCHEME

The Department of Agriculture for Northern Ireland hereby gives Notice in pursuance of Article 12 of the Drainage (Northern Ireland) Order 1973 (as amended by the Drainage (Environmental Assessment) Regulations (Northern Ireland) 1991) that it proposes to carry out a drainage scheme at the River Bann, Banbridge.

The scheme consists of the construction of a 40 m length of floodwall on the eastern bank of the River Bann immediately upstream of the County Road Bridge in Banbridge, Co. Down, on the river side of the existing defective structure.

Having determined that the proposed works are not, by reason amongst other things of their nature, size or location, likely to have significant environmental effects, it is the Department's intention not to prepare an Environmental Statement.

The Betting, Gaming, Lotteries and Amusements (Northern Ireland) Order 1985

The principal amendments -

(a) make it unlawful to discriminate in the provision of goods, facilities and services on the grounds of religious belief or political opinion;

(b) permit a person to -

i. recruit specifically from the unemployed; and

ii. offer religion specific training to persons not already in his employment;

(c) provide a right of appeal against national security certificates;

(d) make provision in relation to the arbitration and settlement of complaints.

The Order also makes certain corresponding amendments to the Sex Discrimination (Northern Ireland) Order 1976 and the Race Relations (Northern Ireland) Order 1997.

The Order will come into operation on a date to be appointed by the Secretary of State.
