The 10th Day of March 1999 PRESENT,

THE QUEEN'S MOST EXCELLENT MAJESTY IN COUNCIL

Whereas by the Civil Service Order in Council 1995 (hereinafter referred to as "the principal Order') provision was made relating to the appointment of persons to situations in Her Majesty's Home Civil Service and for regulating the conduct of Her Majesty's Home Civil Service and the conditions of service therein:

And whereas it is expedient to make further provision for Her Majesty's Home Civil Service in relation to the matters aforesaid:

Now, therefore, Her Majesty is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:-

1. Article 3(2) of the principal Order shall be amended by the insertion, after the words "Minister of the Crown;" of:
"(aa) with the approval of the Minister for the Civil Service and on

terms incorporating conditions approved by him, and".

2. Article 3 of the principal Order shall be amended by the insertion after paragraph (3) of the following mew paragraphs:

"(4) Article 2(1)(a) shall not apply to any situation where the holder is appointed directly by a member of the Scottish Executive

(a) with the approval of the Minister and on terms incorporating conditions approved by him, and

(b) for the purpose only of providing advice to the member of the Scottish Executive, and

(c) for a period which cannot extend beyond the end of the term of office as member of the Scottish Executive of the person whom he is

appointed to advise but no more than twelve situations may be held at any time by persons appointed by virtue of this paragraph.

(5) Article 2(1)(a) shall not apply to any situation where the holder is appointed directly by the Assembly First Secretary of the National Assembly for Wales or an Assembly Secretary

(a) with the approval of the Minister and on terms incorporating conditions approved by him, and

(b) for the purpose only of providing advice to the Assembly First Secretary or Assembly Secretary, and

(c) for a period which cannot extend beyond the end of the term of office as Assembly First Secretary or Assembly Secretary of the person whom he is appointed to advise

but no more than four situations may be held at any time by persons appointed by virtue of this paragraph."

Citation etc.

3.-(1) This Order may be cited as the Civil Service (Amendment) Order in Council 1999 and shall come into force forthwith.

(2) The Interpretation Act 1987 (a) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order amends the Civil Service Order in Council 1995 so as to provide for the approval by the Minister for the Civil Service on terms incorporating conditions approved by him of appointments made under Article 3(2) of that Order and so as to include in the exemptions made in Article 3 of that Order appointments to a limited number of situations made with the approval of the Minister for the Civil Service on terms incorporating conditions approved by him and made for the purpose only of providing advice to a member of the Scottish Executive or to the Assembly First Secretary or an Assembly Secretary of the National Assembly for Wales.

National Savings

Fixed Interest National Savings Certificates – New Issue 50th issue Savings Certificates go on sale from 19th March 1999. They will grow in value at a guaranteed rate each year as follows:

Roads (NI) Order Department of The Environment


ROAD HUMPS REGULATIONS (NI) 1999




